RESOLUTION NO. 2014-232

*A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE ACF-INTERNATIONAL (ACF) REPRESENTED BY ITS COUNTRY DIRECTOR, JAVAD AMOOZEGAR, AND THE THIRTEEN (13) BARANGAYS OF ORMOC CITY REPRESENTED BY THEIR RESPECTIVE PUNONG BARANGAYS FOR THE IMPLEMENTATION OF THE PROJECT ENTITLED: "RESTORING THE ACCESS TO WATER, SANITATION, AND HYGIENE OF THE POPULATIONS AFFECTED BY TYPHOON HAIYAN IN THE PHILIPPINES IN 2013" TO BE FUNDED BY THE DEPARTMENT OF FOREIGN AFFAIRS AND TRADE DEVELOPMENT OF CANADA (DAFTD).*

WHEREAS, an urgent indorsement dated December 3, 2014 from the Honorable City Mayor Edward C. Codilla was received by this Sanggunian requesting for the passage of a resolution authorizing him to enter and sign the MOA for and on behalf of LGU-Ormoc with the ACF-International represented by its Country Director, Javad Amoozegar, and the Thirteen (13) Barangays of Ormoc City represented by their respective Punong Barangays for the implementation of the project entitled: "RESTORING THE ACCESS TO WATER, SANITATION, AND HYGIENE OF THE POPULATIONS AFFECTED BY TYPHOON HAIYAN IN THE PHILIPPINES IN 2013" to be funded by the Department of Foreign Affairs and Trade Development of Canada;

WHEREAS, ACF-International or Action Contre La Faim/Action Against Hunger is an international humanitarian non-government organization committed among others to saving lives of malnourished children while providing communities with sustainable access to safe drinking water through, among others, the drilling of wells, the tapping of springs, and the installation of water systems. Furthermore, the organization works towards the strengthening of the local members and communities through the conduct of trainings, as an effort to maintain equipment and collaborate with local populations on the issue of potable drinking water;

WHEREAS, in line with its commitment, ACF-International is in the lead of implementing a project which aim is to support the Typhoon Haiyan affected communities by contributing to minimize public health risks, mortality, and morbidity in areas affected by Typhoon Haiyan through Water, Sanitation and Hygiene (WASH) interventions;

WHEREAS, the LGU-Ormoc is mandated under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to provide its constituents with basic services and facilities essential to the promotion of general welfare including among others, the development of adequate water supply systems and the promotion of proper sanitation and hygiene;

WHEREAS, the above-enumerated Thirteen (13) barangays of Ormoc City were found to be indeed in considerable need of water system development and sanitation and hygiene promotion projects that will immensely benefit the people living in said barangays for being the direct beneficiaries of this ACF Project;

WHEREAS, the MOA clearly defines the roles and responsibilities of all parties in the implementation of the aforesaid project and that of LGU-Ormoc is determined to be not that onerous;

WHEREAS, this Sanggunian after thorough examination of the provisions therein, finds that it is not contrary to law, public policy, and public morals, and that the project that is the object thereof and the ends being sought for, are truly immensely beneficial to the residents of the subject barangays and to LGU-Ormoc in general, and therefore most deserving of this august Body's prompt and favorable action, and this august Body makes use of this occasion to formally convey its profound gratitude to the ACF-International for such magnanimous act of great kindness and compassion in restoring and uplifting the lives of the people in Typhoon Haiyan affected communities such as the City of Ormoc through the implementation of projects contained in the MOA;


