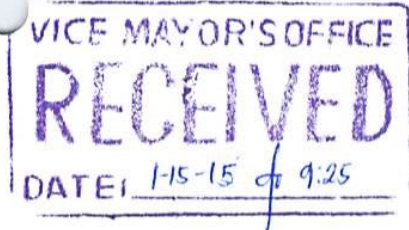

*A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR  
EDWARD C. CODILLA FOR THE SUSPENSION OF WORK IN  
THE CITY GOVERNMENT OFFICES AND CLASSES IN  
PUBLIC AND PRIVATE SCHOOLS IN ORMOC CITY ON  
JANUARY 16, 2015 IN VIEW OF THE PAPAL VISIT.*

WHEREAS, this august Body was in receipt of a letter from Rev. Msgr. Rex C. Ramirez, Vicar General and concurrent Executive Secretary of the Archdiocese of Palo, requesting for the declaration of January 15, 16 and 17, 2015, as non-working holidays in Ormoc city in view of the visit of His Holiness Pope Francis, Head of State of Vatican City and Vicar of Christ, to Tacloban City and the Municipality of Palo, Province of Leyte, on January 17, 2015, a copy of said letter request is attached as Annex A and made an integral part hereof;

WHEREAS, the City was also in receipt of various requests from the Office of the Governor of Leyte Province and the DOH Regional Office 8 for volunteers and medical/rescue team to augment and assist their existing teams during the Papal Visit, copies of said requests are attached as Annexes B and C respectively, and made integral parts hereof;

WHEREAS, further, there has been a strong clamor from both the private and public sectors in the City for a declaration of a day off from work in order to allow them ample time to prepare and participate in said Papal Visit;

WHEREAS, the said requests are found to be worthy of merit and favorable action not only for the safety and convenience of the City's residents who want to join in the Papal Visit in said venues, but also for those who want to attend the same in view of the fact that the City of Ormoc is anticipated to be a dropping or transition point in consideration of its strategic location and proximity for visitors coming from other cities and municipalities;
