RESOLUTION NO. 2015-012

A RESOLUTION DECLARING THAT TAX ORDINANCE NO. 2014-02 OF BARANGAY DON FELIPE LARRAZABAL, ORMOC CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY DON FELIPE, ORMOC CITY" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION."

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received a copy of Tax Ordinance No. 2014-02 of Barangay Don Felipe Larrazabal, this city, entitled: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY DON FELIPE, ORMOC CITY", copies of the Ordinance together with its attachments are hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the aforesaid Ordinance was submitted to this august Body pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 of the Republic Act 7160, otherwise known as the Local Government Code of 1991 (LGC), in order to find out if the Tax Ordinance under review is in conformity with existing laws and city ordinances;

WHEREAS, the Ordinance is anchored on the concerned Barangay's vested revenue-raising authority under Secs. 152 and 153 of the LGC, and its inherent power to formulate and create its own sources of revenue through among others, the levying of taxes and the imposition of fees and charges for barangay clearances, certifications and installation of billboards, signages, neon signs and outdoor advertisements, in order to raise much needed barangay funds for the delivery of public needs and services to the community;

WHEREAS, this Sanggunian in the exercise of its said review powers, and after thorough examination of the subject Ordinance, finds that the same is indeed in conformity and compliance with existing applicable laws and city ordinances, particularly the requirement for the conduct of a public hearing in the case of tax and revenue-raising ordinances in accordance with the LGC's Implementing Rules and Regulations, and further, deems that its enactment is most beneficial to the concerned Barangay, especially in the delivery of public service to its constituents, therefore, deserving of this august Body's approval and its interposition of no objection to its implementation;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION DECLARING THAT TAX ORDINANCE NO. 2014-02 OF BARANGAY DON FELIPE LARRAZABAL, ORMOC CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY DON FELIPE, ORMOC CITY" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION.";
