RESOLUTION NO. 2015-017

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE NO. 8 FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS FOR CY 2014.

WHEREAS, presented to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an endorsement dated January 6, 2015, from the Office of the City Mayor relative to the request of Mr. Manuelito Z. Estela, OSCA Head, recommending the passage of a Resolution authorizing Ormoc City Mayor Edward C. Codilla to enter and sign the Memorandum of Agreement (MOA) by and between the Department of Social Welfare and Development Regional Office No. 8 and the Local Government Unit of Ormoc City for the implementation of the Social Pension for Indigent Senior Citizens, a photocopy of the final and revised MOA of which is hereto attached and made an integral part hereof;

WHEREAS, the Department of Social Welfare and Development is continuously implementing programs/projects through technical assistance and resource augmentation for the Local Government Unit (LGU) in order to help alleviate poverty and ensure the welfare of the disadvantaged and vulnerable groups;

WHEREAS, the Social Pension for Indigent Senior Citizens is an additional government assistance to augment the daily subsistence and other medical needs of indigent senior citizens;

WHEREAS, the Social Pension for Indigent Senior Citizens is the provision of monthly pension to qualified senior citizens in the amount of Five Hundred Pesos (P500.00) as government assistance stipulated under Republic Act 9994 otherwise known as "The Expanded Senior Citizens Act of 2010";

WHEREAS, fund transfer to LGU is identified as a mode of payment to fast track the distribution of stipend to the beneficiaries and to strengthen the partnership with LGUs in the effective delivery of programs and services;

WHEREFORE, on joint motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE NO. 8 FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS FOR CY 2014;
