RESOLUTION 2015-019

RESOLUTION DECLARING THAT ORDINANCE NO. 003 S-2014 OF THE SANGGUNIANG BARANGAY OF BARANGAY COGON, THIS CITY, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISION OF BARANGAY ORDINANCE NO. 2008-002, ENTITYED: "AN ORDINANCE PROHIBITING RESIDENTS THIS BARANGAY THE INDISCRIMINATE FROM THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF" UNDER REVIEW, TO BE NOT INCONSISTENT WITH **EXISTING** LAWS AND CITY ORDINANCES AND INTERPOSING NO OBJECTIONS TO ITS IMPLEMENTATION PROVIDED THAT THE RECOMMENDED AMENDMENTS ARE ADOPTED BY THE SANGGUNIAN CONCERNED.

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc has received a copy of Ordinance No. 003 S-2014 enacted by the Sangguniang Barangay of Barangay Cogon, Ormoc City, entitled: "AN ORDINANCE AMENDING SOME PROVISION OF BARANGAY ORDINANCE NO. 2008-002, **ENTITLED:** ORDINANCEPROHIBITING RESIDENTS OF THIS BARANGAY INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF", a copy of the Ordinance together with its attachments are hereto attached and made an integral part hereof;

WHEREAS, the Ordinance was submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Sections 458 and 57 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" (LGC) in order to find out whether the subject Ordinance approved by the Sangguniang Barangay is within the scope of its prescribed powers and also whether the same is not inconsistent with law or city ordinances;

WHEREAS, the Ordinance was enacted by the concerned barangay pursuant to its mandate of the promotion of health and safety in the Barangay and the enhancement of the right of its people to a balanced ecology in accordance with Section 16 of the LGC;

WHEREAS, it can be recalled that the Eleventh Sangguniang Panlungsod ng Ormoc had passed and approved SP Resolution No. 2008-117, dated June 26, 2008 entitled: "A RESOLUTION APPROVING ORDINANCE NO. 2008-002 OF THE BARANGAY COUNCIL OF BARANGAY COGON, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF."

WHEREAS, the Ordinance is an amendatory one which aims to achieve noble and lofty goals as it seeks to improve, ensure and support, among other things, the quality of life of the inhabitants of the concerned barangay thru a balanced ecology and a clean and healthy environment, by imposing tougher penalties for individuals who indiscriminately throw garbage within the territory of the Barangay;

WHEREAS, the Ordinance aims to respond to changing needs and situation by strengthening the existing one thru the amended provisions;

WHEREAS, this Sanggunian, after thorough examination and review, although favoring the enactment of the Ordinance for its validity and legality as well as its noble ends and purposes, however, found that certain provisions of the same under review need to be further modified and amended in order to have them conform to and be compliant with applicable laws, ordinances and rules and regulations, and considering further that subject recommended modifications are not that substantial and of the Ordinance's urgency and necessity, the outright return of the Ordinance is no longer deemed appropriate or feasible, hence this resolution, approving the same subject to the compliance of the modifications and amendments found herein;

WHEREAS, the recommended modifications and amendments to be incorporated and effected on the Ordinance are the following:

- 1. Section 4 entitled 'Penalties' shall be modified so that the phrase 'and filing the appropriate charge in court' for the first, second and third offenses shall now read 'or filing the appropriate charge in court'; this is because the filing of court charges shall only become operative after the failure by the offender to pay the stated fines.
- 2. The word 'metered' in the second line of Section 4 shall be corrected to 'meted', an apparent typographical error.
- 3. The Ordinance, being one with penal sanctions, shall comply with the posting requirement as provided for in Section 511 (a) of the LGC.
