RESOLUTION NO. 2015-024

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), THE OXFAM, REPRESENTED BY ITS EMERGENCY FOOD SECURITY AND VULNERABLE LIVELIHOODS (EFSVL) TEAM LEADER, SYLVIE LE GUEVEL, AND THE MABINI COCONUT FARMER'S ASSOCIATION (MACFA), REPRESENTED BY ITS CHAIRMAN, LORETO LUZ S. PATON-OG, FOR THE ESTABLISHMENT OF COMMUNITY - BASED GOAT BREEDING/PRODUCTION CENTER AT BARANGAY MABINI, ORMOC CITY.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated January 15, 2015 relative to the preceding 1st Indorsement from the City Agriculturist, Joseph C. Cortes, recommending for the passage of a resolution authorizing the Hon. City Mayor to enter and sign the MOA by and between the Local Government Unit of Ormoc (LGU-Ormoc), the OXFAM, represented by its EFSVL, Team Leader, Sylvie Le Guevel and the Mabini Coconut Farmer's association (MACFA), represented by its Chairman, Loreto Luz S. Paton-og, for the establishment of Community - Based Goat Breeding/Production Center at Barangay Mabini, Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, OXFAM is an International Non-Government Organization which purpose is to help create lasting solutions to the injustice of poverty and which is part of a global movement for change, empowering people to create a future that is secure, just, and free from poverty;

WHEREAS, MACFA is a farmers organization which is based in Barangay Mabini, Ormoc City;

WHEREAS, OXFAM aims to support the establishment of a community-based goat breeding/production center at Barangay Mabini, Ormoc City, as an alternative livelihood for farming communities affected by typhoon Yolanda in November 2013;

WHEREAS, LGU-Ormoc has expressed willingness and commitment to share human resources with OXFAM to help and assist in establishing a sustainable and profitable enterprise thru community-based goat breeding/production center to be managed by MACFA;

WHEREAS, LGU-Ormoc, thru the City Agriculture Office (CAO), shall ensure the sustainability of the project implementation and operation in the community and be part of the regular activity even after OXFAM's exit, as well as support MACFA in the project implementation and management beyond OXFAM's intervention;

WHEREAS, MACFA has signified great interest and willingness in actively participating in the establishment and operation, of community-based goat breeding/production center, as well as commits, among others, to provide counterpart such as labor, indigenous materials and other needs that may arise during the implementation which are not provided by OXFAM;

WHEREAS, further, OXFAM will procure and provide the identified materials needed for the establishment of community-based goat breeding/production center;

WHEREAS, the subject MOA will be implemented following a specific work plan that specifically describes the joint activities to be carried out and is consistent with the goals and objectives of the Community-Based Goat Breeding/Production Center;

WHEREAS, the concerned parties are mutually committed in collaborating for the successful establishment of Community-Based Goat Breeding/Production Center, subject to their corresponding specific obligations and responsibilities as stipulated in the MOA, and this Sanggunian, after close and thorough review of the same, finds that it is indeed extremely beneficial to the constituents of Barangay Mabini, most especially to the benefitted local farmers, and to the City in general, and so therefore, most deserving of this august Body's utmost support and favorable consideration with the august Body, additionally, taking this special occasion to express its utmost recognition and appreciation of OXFAM's profound magnanimity in coming to Ormoc's aid and assistance in its recovery and rehabilitation endeavors post-Yolanda;

WHEREFORE, on joint motion of Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries and Honorable Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga and John Eulalio Nepomuceno O. Aparis II; be it


ADOPTED, February 05, 2015.

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be furnished to this Sanggunian for its information and files;


