RESOLUTION 2015-026

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BENALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH) REGIONAL OFFICE NO. VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, JOSE R. LLACUNA JR., COVERING THE DOH GRANT IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FOR SUSTAINABLE IMPLEMENTATION OF THE DOH EXPANDED PROGRAM ON IMMUNIZATION (EPI) IN THE CITY OF ORMOC.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Honorable City Mayor Edward C. Codilla dated January 27, 2015, requesting therein for the passage of a resolution authorizing the Hon. City Mayor to enter and sign the MOA for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Department of Health (DOH) - Regional Office No. VIII, represented by its Regional Director, Jose R. Llacuna Jr., for the implementation of the Expanded Program on Immunization (EPI) of DOH, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the DOH has issued Department Order No. 2014-0074 dated April 21, 2014 which is the Sub-Allotment Guidelines on the Transfer and Utilization of Government Funds to the different DOH Regional Offices, to be used for Measles Rubella and Oral Polio Vaccine Mass Immunization (MR OPV MI) program, which was implemented in September 2014, to attain control of measles and poliomyelitis through the DOH Expanded Program on Immunization (EPI);

WHEREAS, after the said MR-OPV MI program was implemented, there was an unutilized balance for which the DOH may reprogram the said amount to finance other EPI related priority activities as provided in DO No. 2014-74;

WHEREAS, the DOH Execom, per Execom Resolution No.11 dated December 2, 2014 unanimously decided to reprogram the unutilized sub-allotment for the MR and OPV – MI Program, and use the same as additional grant to provinces, cities and municipalities in Region VIII, which garnered at least 95% MR-OPV immunization coverage, as incentive for Best Performing LGUs as augmentation fund for the sustainable implementation of the EPI program;

WHEREAS, the LGU-Ormoc is among those LGUs which achieved MR of 96.2% and OPV of 95.4% coverage and entitled to receive the grant amounting to FIFTY THOUSAND PESOS (P50,000.00), the utilization of which shall be in accordance with the purpose specified in the MOA;

WHEREAS, the concerned parties are mutually committed in collaborating for the successful and sustainable implementation of the DOH Expanded Program on Immunization, subject to the specific obligations and responsibilities of both parties as stipulated in the MOA;

WHEREAS, this Sanggunian finds, after close and thorough review of the subject MOA, that the DOH Expanded Program on Immunization will help reduce the morbidity and mortality among children against the most common vaccine-preventable diseases and the same will indeed immensely benefit the underprivileged, and therefore, is most deserving of its prompt favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Eusebio Gerardo S. Penserga, Vice-Chairman, Committee on Health and Sanitation, and Honorable Benjamin S. Pongos, Jr., Chairman Committee on Laws and Ordinances, severally seconded by Honorable SP Members Mario M. Rodriguez, Tomas R. Serafica, Ruben R. Capahi, Pedro Godiardo P. Ebcas and Vincent L. Rama; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH) REGIONAL OFFICE NO. VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, JOSE R.
