RESOLUTION NO. 2015-034

A RESOLUTION DECLARING THAT ORDINANCE NO. 2015-004 OF THE SANGGUNIANG BARANGAY OF BARANGAY COGON, ORMOC CITY, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISION IN ACCORDANCE OF BARANGAY ORDINANCE NO. 2007-03 PER SANGGUNIANG PANLUNGSOD RESOLUTION 2007-101 ENTITLED "AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMITS AND OTHER CHARGES"" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND CITY ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION PROVIDED THAT A RECOMMENDED MODIFICATION IS ADOPTED BY THE CONCERNED SANGGUNIAN.'

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received a copy of Ordinance No. 2015-004 of the Sangguniang Barangay of Barangay Cogon, Ormoc City, entitled: 'AN ORDINANCE AMENDING SOME PROVISION IN ACCORDANCE OF BARANGAY ORDINANCE NO. 2007-03 PER SANGGUNIANG PANLUNGSOD RESOLUTION 2007-101 ENTITLED 'AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES, PERMITS AND OTHER CHARGES", a copy of the Ordinance with it attachments is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the aforesaid Ordinance was submitted to this august Body pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in order to find out if the Ordinance is in conformity with existing laws and city ordinances, and was enacted within the scope of the powers of the Sangguniang Barangay;

WHEREAS, it can be recalled that the Ordinance which is subject for amendment by this amendatory Ordinance is Tax Ordinance No. 2007-03 of the Barangay which was approved by the Tenth Sangguniang Panlungsod ng Ormoc through the passage of SP Resolution No. 2007-101 dated May 10, 2007;

WHEREAS, the amendatory Ordinance was enacted by the Barangay in order to raise and augment its financial resources to respond to the increasing costs of various needs and to effectively carry out its mandate of providing for public services to its constituents thru increased rates on the issuance of barangay clearances, permits and other charges by the barangay, hence, the amended provisions;

WHEREAS, this Sanggunian, upon close examination and thorough review of the Ordinance, has determined that a public hearing was duly conducted in accordance with legal requirements on October 18, 2014 at the barangay gym, and that though finding the enactment to be valid and legal overall, nonetheless, recommends that a provision thereon be modified and amended, more particularly, Section 2 (7) of the same, such that the same should read 'Other charges for other services rendered PP300' in order to be clear that such charges are for those services rendered by the Barangay not included among the activities specifically charged in other parts of the Ordinance;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
