RESOLUTION NO. 2015-043

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE CONTRACT OF SERVICE (RENEWAL) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH), REPRESENTED BY ITS REGIONAL DIRECTOR, DR. JOSE R. LLACUNA, JR., AND MS. SHARMAIN C. GALENZOGA (MIDWIFE) FOR THE CONTINUOUS IMPLEMENTATION OF THE DOH RURAL HEALTH MIDWIVES PLACEMENT PROGRAM (RHMPP).

WHEREAS, an indorsement dated February 17, 2015 from the Honorable City Mayor Edward C. Codilla was received by this Sanggunian anent the indorsement coming from Dr. Nelita D. Navales, City Health Officer II, requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the Contract of Service (Renewal) for and on behalf of LGU-Ormoc with the Department of Health (DOH), represented by its Regional Director, Dr. Jose R. Llacuna, Jr., and Ms. Sharmain C. Galenzoga, Midwife, a photocopy of the final Contract is hereto attached and made an integral part hereof;

WHEREAS, the Contract of Service subject for renewal is for the continuous implementation of the DOH Rural Health Midwives Placement Program (RHMPP) and specifically covers the "Return Service" of Ms. Sharmain Galenzoga in Ormoc City in connection with her 2-Year Midwifery Scholarship from the DOH- RHMPP under which she agreed to serve and render service to Ormoc for a period of Four (4) years upon completion of the scholarship grant;

WHEREAS, it can be recalled that the original Contract for the "Return Service " of Ms. Sharmain Galenzoga had been acted upon by this Sanggunian through SP Resolution No. 2014-163 dated September 18, 2014 which duration is good for Six (6) months only commencing last June 2, 2014 until December 31, 2014;

WHEREAS, in view of the expiration of the previous Contract, and considering that the concerned parties mutually agreed for the continuous implementation of said "Return Service" of Ms. Galenzoga in Ormoc City, there is a need to have this Renewal Contract acted upon favorably for its outright execution in accordance with the terms and conditions laid therein;

WHEREAS, upon thorough examination of the new Contract, this Sanggunian finds the provisions to be in order, the period being covered is also good for another Six (6) months effective January 2015 until June 2015, and further, this august Body deems that the same is indeed beneficial to the City of Ormoc as the continued engagement of the services of Ms. Galenzoga will augment the City Health Office' workforce particularly in the delivery of midwives' health services at no additional personnel cost as the salary of Ms. Galenzoga shall be borne by the DOH;

WHEREFORE, foregoing premises considered, on joint motions of Honorable SP Members Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances and Vice Chairman, Committee on Health, Honorable SP Member Eusebio Gerardo S. Penserga, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a *RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE CONTRACT OF SERVICE (RENEWAL) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH), REPRESENTED BY ITS REGIONAL DIRECTOR , DR. JOSE R. LLACUNA, JR., AND MS. SHARMAIN C. GALENZOGA (MIDWIFE) FOR THE CONTINUOUS IMPLEMENTATION OF THE DOH RURAL HEALTH MIDWIVES PLACEMENT PROGRAM (RHMP)*;
