RESOLUTION NO. 2015-050

A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR, HONORABLE EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL OFFICE NO. 8, REPRESENTED BY ITS REGIONAL DIRECTOR NESTOR RAMOS, FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS IN CY 2015.

WHEREAS, it is the policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation through policies that provide adequate social services;

WHEREAS, Republic Act No. 9994 otherwise known as "Expanded Senior Citizens Act of 2010" has been enacted in response to such declared policy of the state;

WHEREAS, such law provides for a social pension which entitles indigent senior citizens to a monthly stipend amounting to Five Hundred Pesos (P500.00) to augment the daily subsistence and other medical needs of our Senior Citizens;

WHEREAS, the Office for Senior Citizens Affairs (OSCA) is tasked to plan, implement and monitor yearly work programs in pursuance of the objective of said Act and to monitor compliance of the provisions thereof particularly the grant of privileges to senior citizens;

WHEREAS, the office of the City Mayor through an indorsement dated February 25, 2015, has forwarded to this Sanggunian the letter of Ms. Mansueta Teleron, OSCA Head, in relation to the need of a Memorandum of Agreement to be entered into by and between the City of Ormoc and Department of Social Welfare and Development (DSWD) – Field Office No. 8 and further requesting that the Honorable City Mayor be granted authority to sign the said agreement;

WHEREAS, a new MOA is necessary to be entered into between LGU – Ormoc and DSWD on a yearly basis because the number of beneficiaries or pensioners is increasing every year;

WHEREAS, the agreement is deemed beneficial to a greater number of our indigent Senior Citizens;


