RESOLUTION NO. 2015-053

A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC OF VALENCIA-MONTEBELLO-KANANGA MULTICAB OPERATORS' AND DRIVERS ASSOCIATION (OVMKMODA) IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO.009 DATED OCTOBER 16, 2014.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received the application of Valencia-Montebello-Kananga Multicab Operators' and Drivers Association (OVMKMODA), a Non-government Organization (NGO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: " AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC". The Ordinance governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) day period within which application for accreditation for membership in Local Special Bodies by any organization shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of OVMKMODA's application, finds that the same is in order and the purpose of the sought accreditation is for the realization of the organization's noble intention to be able to assist and work hand in hand with the LGU particularly in improving the traffic and other transportation related problems involving Multicab vehicles;
