CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMO() WITH THE DEPARTMENT OF TRADE AND INDUSTRY (DTI), REPRESENTED BY THE REGIONAL/PROVINCIAL DIRECTOR, RELATIVE TO SETTING UP OF TIMBANGAN NG BAYAN WEIGHING SCALES AND SCALE HOUSING IN THE ORMOC CITY PUBLIC MARKET.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated March 31, 2015 relative to the preceding communication from the OIC- Public Market Administrator, Arthur C. Arcuino, recommending therein the passage of a resolution authorizing the Honorable City Mayor to enter and sign the MOA by and between the Local Government Unit of Ormoc (LGU-ORMOC), with the Department of Trade and Industry (DTI) for the "Timbangan ng Bayan Project" for the Ormoc City Public Market, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, under Republic Act No. 7394, otherwise known as the Consumer Act of the Philippines, the municipal treasurer implements the provisions thereof relative to the regulation of weights and measures;

WHEREAS, the DTI, in pursuit of its mandate to protect consumers from fraudulent and unconscionable sales practices and acts, adopts measures to ensure that the buying public get value for their money through the use of accurate weighing scales;

WHEREAS, the DTI has implemented the Timbangan ng Bayan project for the installation of accurate weighing scales and scale housing to public market beneficiaries in the different municipalities and cities all over the Philippines,

WHEREAS, LGU-Ormoc is one of those LGU's whose public market has been identified as recipient of the Timbangan ng Bayan Project;
