RESOLUTION NO. 2015-073

A RESOLUTION DECLARING THAT ORDINANCE NO. 2015-003 OF THE SANGGUNIANG PAMBARANGAY OF BARANGAY DISTRICT XIII, THIS CITY, ENTITLED: "AN AMENDATORY ORDINANCE PROVIDING ADDITIONAL ITEM TO SECTION 5, ORDINANCE NO. 2014-001, ENTITLED: " AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY DISTRICT XIII, ORMOC CITY" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION.

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received a copy of Ordinance No. 2015-003 of Barangay District XIII, Ormoc City, entitled: : "AN AMENDATORY ORDINANCE PROVIDING ADDITIONAL ITEM TO SECTION 5, ORDINANCE NO. 2014-001, ENTITLED: " AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY DISTRICT XIII, ORMOC CITY" a copy of the Ordinance together with its attachments are hereto attached and made an integral part hereof;

WHEREAS, the ordinance was submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" (LGC) in order to find out whether the subject Amendatory Ordinance approved by the Sangguniang Barangay under review is in conformity with law and city ordinances;

WHEREAS, it can be recalled that Ordinance No. 2014-001 of Barangay District XIII which is the subject for amendment by this Amendatory Ordinance No. 2015-003 has been approved by this Sanggunian through SP Resolution No. 2014-030, dated February 20, 2014;

WHEREAS, the aforesaid Amendatory Ordinance No. 2015-003 which purpose is to provide privileges and benefits to the senior citizens and indigent persons living within the territorial jurisdiction of Barangay District XIII by exempting them from payment for the issuance of certification/clearances issued by the Barangay relevant to their indigency and insufficient income is in consonance with the General Welfare provision of the Local Government Code of 1991;

WHEREAS, this Sanggunian in the exercise of its said review powers, and after thorough examination of the subject ordinance, finds that the same is indeed in conformity and compliance with existing applicable laws and city ordinances, most notably including the compliance for the conduct of a public hearing in the case of revenue-raising ordinances in accordance with the LGC's Implementing Rules and Regulations, and further, deems that its enactment is most beneficial to the Senior Citizens and Indigent Persons in said barangay, therefore, deserving of this august Body's approval and its interposition of no objection to its implementation;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos, Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Pensergera, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
