RESOLUTION NO. 2015-090

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE ORMOC CITY MAYOR EDWARD C. CODILLA, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SAVE THE CHILDREN PHILIPPINES, REPRESENTED BY THE SCI WESTERN LEYTE FIELD MANAGER, REGGIE AQUINO, FOR THE REPAIR/REHABILITATION/CONSTRUCTION OF THIRTY (30) DAY CARE CENTER FACILITIES LOCATED IN DIFFERENT BARANGAYS, THIS CITY, AFFECTED BY SUPER TYPHOON YOLANDA.

WHEREAS, an Urgent Indorsement was received by this Thirteenth Sangguniang Panlungsod Ng Ormoc dated May 5, 2015 from the Office of the City Mayor relative to the preceding 1<sup>st</sup> Indorsement from the OIC-City Legal Officer, Atty. Ivan B. Verallo, recommending therein the passage of a resolution authorizing the Honorable City Mayor to enter into and sign a MOA by and between the LGU-ORMOC with the Save the Children Philippines, represented by its SCI Western Leyte Field Manager, Reggie Aquino, for the Repair/Rehabilitation/Construction of Day Care Center Facilities in thirty (30) barangays in Ormoc City affected by Super Typhoon Yolanda, a photocopy of the final MOA and its annexes are hereto attached and made an integral part hereof;

WHEREAS, Save the Children Philippines is an international non-government organization working in partnership with governments, foundations, corporations, national and international agencies to uphold children's rights;

WHEREAS, several educational facilities in Ormoc City including Day Care Center facilities were seriously damaged by the onslaught of Super Typhoon Yolanda and became totally non-functional or only partially functional thereby depriving children in the local barangay population who are in vital need of access to quality educational services thru said facilities;

WHEREAS, Save the Children Philippines as part of its humanitarian and compassionate endeavors to assist and provide support to the Yolanda-affected communities in the City, desires to undertake the repair/rehabilitation/construction of thirty (30) damaged Day Care Centers in different barangays in the City, which is the subject of this MOA, which is principally in line with its benevolent commitment to make lasting changes in children's lives by implementing programs geared towards relief and emergency response;

WHEREAS, the MOA clearly sets forth the responsibilities and undertakings of the Save the Children Philippines in the accomplishment of the projects to be carried out in the benefitted barangays, in accordance with funding limitations determined by them, and also the commitment of LGU-Ormoc, thru its relevant authorities, and other related agencies, in providing for all the necessary non-monetary assistance and support to ensure the smooth and speedy implementation of the repair/rehabilitation and construction of the benefitted Day Care Centers;

WHEREAS, the parties thereto have agreed to perform faithfully and committedly their respective roles and responsibilities towards the achievement and implementation of the goals of the MOA, and this Sanggunian finds, after close and thorough examination of the same, that the MOA is extremely beneficial to the City, most especially to the benefitted barangays and its constituents who are in great need of the mentioned assistance provided by the Save the Children Philippines, and therefore, is most worthy of this august Body's prompt favorable action and support, and for which reason, this Sanggunian additionally takes on this special occasion to formally express and convey its wholehearted appreciation and most profound commendation to the Save the Children Philippines for such immense display of magnanimity and benevolence in helping the City tremendously in its recovery and rehabilitation endeavors post-Yolanda;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Honorable SP Member Pedro Godiardo P. Ebcas, Vice-Chairman, Committee on Infrastructure Development, severally seconded by Honorable SP Members Mario M. Rodriguez, Ruben R. Capahi, Antonio M. Codilla, Vincent L. Rama, Nepomuceno O. Aparis II and Mariano Y. Corro; be it


