RESOLUTION NO. 2015-091

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE GRANDT PLANNERS, INC (GPI), REPRESENTED BY ITS PRESIDENT, MS. GRACE C. RAMOS, FOR THE FORMULATION/UPDATING OF ORMOC CITY COMPREHENSIVE LAND USE PLAN (CLUP).

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated March 16, 2015 relative to the preceding 3rd Indorsement of Engr. Raoul E. Cam, City Planning and Development Coordinator, recommending therein the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to enter and sign the Memorandum of Understanding (MOU) by and between the Local Government Unit of Ormoc (LGU-ORMOC) and Grandt Planners, Inc., represented by its President, Ms. Grace C. Ramos, for the formulation/updating of the Ormoc City Comprehensive Land Use Plan (CLUP), a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, the Association of Southeast Asian Nations (ASEAN), through the Assistance for the Recovery of Yolanda-affected Areas (ARYA) Project steering Committee, seeks to extend Strategic Assistance for the Recovery and Rehabilitation of the Areas affected by Typhoon Yolanda in the Philippines, herein referred to as the "Project";

WHEREAS, ARYA Project Steering Committee choose the City of Ormoc as one of the Four (4) pilot sites for the formulation/updating of CLUP;

WHEREAS, the ASEAN, through a Special Services Agreement, commissioned GPI as the Consultant for the aforesaid project and in line thereto LGU Ormoc commits to provide them with all the necessary data to formulate/update the existing CLUP of the City;

WHEREAS, there is a need for LGU-Ormoc to lay-out a comprehensive land use plan that incorporates disaster resilience principles with its long-term vision for the City, thus the technical assistance that can be provided by GPI in the process of the CLUP formulation/updating is deemed important and highly beneficial to the City of Ormoc;

WHEREAS, both parties agreed to carry out the proposed formulation/updating of the Comprehensive Land Use Plan (CLUP) of Ormoc City, subject to the terms and conditions set forth in the agreement;

WHEREAS, the MOU absolutely encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and responsibilities, pertaining to the said Project, and this Sanggunian, upon thorough review of the MOU, finds that the same will indeed significantly benefit the City, and therefore, is most deserving of this august Body's favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Rolando M. Villasencio, Chairman, Committee on Zoning, Housing & Land Use and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Ruben R. Capahi, Vincent L. Rama, Antonio M. Codilla, Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno P. Aparis II and Mariano Y. Corro; be it


ADOPTED, May 14, 2015.
