A RESOLUTION GIVING CONCURRENCE TO THE APPOINTMENT

GOVERNMENT DEPARTMENT HEAD I (CITY LEGAL
OFFICER), THIS CITY, EFFECTIVE MAY 4, 2015.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received an Urgent Indorsement dated May 11, 2015 from the Honorable City Mayor Edward C. Codilla on the matter of the appointment of Atty. Ivan B. Verallo as City Government Department Head I (City Legal Officer for the City Government of Ormoc City) effective May 4, 2015, requesting for the concurrence by this Sanggunian;

WHEREAS, said appointment concurrence request was made in accordance with Section 454 Paragraph (D) of Chapter 2 (City Officials in General) of R.A. 7160, otherwise known as the Local Government Code of 1991, which provides that:

"X X X, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of the Sangguniang Panlungsod Members, subject to civil service law rules and regulations. X X X"(Underscoring supplied).

WHEREAS, upon close evaluation and examination by this Sanggunian of the appointee's qualifications and fitness to hold the public office relative to subject appointment, it is this august Body's findings that indeed he possesses all the qualifications and none of the disqualifications provided by law, that he is substantially equipped with the necessary skills and proper demeanor required in order to fittingly and faithfully carry out all the duties and functions of the vital and challenging position of CITY LEGAL OFFICER of LGU Ormoc, and that his subject appointment is in accordance with the standards prescribed by the Civil Service Commission;






