A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) AND OTHER PERTINENT DOCUMENTS SUPPLEMENTARY THERETO WITH THE DEPARTMENT OF TRADE AND INDUSTRY REGION VIII, REPRESENTED BY ITS ASSISTANT SECRETARY BLESILA A. LANTAYONA, FOR THE IMPLEMENTATION OF THE GRASSROOTS PARTICIPATORY BUDGETING (GPB) PROJECTS IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED SIXTY THOUSAND PHILIPPINE PESOS (PHP3,760,000.00) SIGNIFYING APPROVAL OF THE PROJECTS IDENTIFIED AND ACCEPTANCE OF THE TERMS AND CONDITIONS THEREBY AMENDING SP RESOLUTION NO. 2014-144 DATED AUGUST 21, 2014.

WHEREAS, this Sanggunian received a communication dated May 22, 2015 from the Office of the Honorable City Mayor Edward C. Codilla relative to the preceding letter from the Regional Director, Cynthia R. Nierras proposing amendments to the MOA covering the implementation of the GPB Projects, formerly known as Bottom-Up Budgeting (BuB), in LGU-ORMOC amounting to THREE MILLION SEVEN HUNDRED SIXTY THOUSAND PHILIPPINE PESOS ONLY (PHP3,760,000.00) as approved by this Sanggunian per SP Res. No. 2014-144 dated August 21, 2014, the final copy of the MOA as approved and corrected by this Resolution is hereto attached as an integral part hereof;

WHEREAS, it can be recalled that thru aforementioned SP Res. No. 2014-117 dated July 10, 2014 entitled: A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC WITH THE DEPARTMENT OF TRADE AND INDUSTRY – REGION VIII, REPRESENTED BY ITS REGIONAL DIRECTOR CYNTHIA NIERRAS, FOR THE IMPLEMENTATION OF THE GRASSROOTS PARTICIPATORY BUDGETING PROJECTS THIS CITY IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED SIXTY PHILIPPINE PESOS ONLY (PHP3,760,000.00), the Honorable City Mayor was granted authority by this Sanggunian to sign the MOA subject thereof;

WHEREAS, again the said SP Resolution was amended as requested by the DTI coursed through the Office of the City Mayor thru SP Res. No. 2014-144 dated August 21, 2014 entitled: A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC AND OTHER PERTINENT DOCUMENTS SUPPLEMENTARY THERETO WITH THE DEPARTMENT OF TRADE AND INDUSTRY REGION VIII, REPRESENTED BY ASSEC ROG BRESILA A. LANTAYONA, FOR THE IMPLEMENTATION OF THE GRASSROOTS PARTICIPATORY BUDGETING PROJECTS IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (P3,760,000.00) SIGNIFYING APPROVAL OF THE PROJECTS AND ACCEPTANCE OF THE TERMS AND CONDITIONS THEREBY AMENDING SP RESOLUTION NO. 2014-117 DATED JULY 10, 2014;

WHEREAS, in reference to the later SP Resolution No. 2014-144, aforementioned recent communication of Regional Director Nierras stated that there were defects found, that of the misspelled name of ASSEC. Blesila A. Lantayona, and the GPB Projects to be implemented not specifically identified thereon, hence, the need to further revise the said Resolution and the subject MOA to correct the same;


