*A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC WITH THE PHILIPPINE COCONUT AUTHORITY (PCA) FOR THE IMMEDIATE ESTABLISHMENT OF LOCAL COCONUT NURSERY UNDER THE YOLANDA RECOVERY AND REHABILITATION PROGRAM (YRRP).*

WHEREAS, an indorsement dated May 18, 2015 from the Office of the City Mayor was received by this august Body relative to the preceding Indorsement from Joseph C. Cortes, DVM, City Agriculturist, concerning the Memorandum of Agreement (MOA) to be made and entered into by and between the Local Government Unit of Ormoc and Philippine Coconut Authority (PCA) for the immediate establishment of Local Coconut Nursery under the Yolanda Recovery and Rehabilitation Program (YRRP) and further recommending for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the subject Memorandum of Agreement (MOA), a copy of which is hereto attached and made an integral part hereof;

WHEREAS, PCA is a government agency under the Office of the Presidential Assistant for Food Security and Agricultural Modernization tasked with the development of the coconut industry to its full potential in line with the new vision of a united, globally competitive and effective industry;

WHEREAS, the PCA and LGU-Ormoc endeavors to work together to address the extreme damage caused by Super typhoon Yolanda to the coconut plantations in Ormoc City through the implementation of immediate replanting activities in affected coconut farms through the Yolanda Recovery and Rehabilitation Program (YRRP);

WHEREAS, the YRRP involves the establishment of local nurseries in the local government units to ensure that seedlings to be planted come from high-yielding sources and free from plant pest and diseases;

WHEREAS, upon perusal by the Officer-In-Charge of the City Legal Office of the subject MOA, it was found out that the MOA is appropriate for implementation;

WHEREAS, this Sanggunian upon close examination and scrutiny, finds the provisions of the MOA to be in order, the implementation of the same is extremely beneficial to the farmer beneficiaries and will contribute much to the city's recovery and rehabilitation endeavors post-Yolanda;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on joint motion of Honorable SP Member Antonio M. Codilla, Chairman, Committee on Agricultural and Industrial Labor & Agrarian Reform and Honorable SP Member Mariano Y. Corro, Vice Chairman, Committee on Laws and Ordinances, severally seconded Honorable SP Members John Eulalio Nepomuceno O. Aparis II, Eusebio Gerardo S. Penserga, Pedro Godiardo P. Ebcas, Vincent L. Rama and Ruben R. Capahi; be it
