RESOLUTION NO. 2015-113

A RESOLUTION DECLARING THAT TAX ORDINANCE NO. 2015-001 OF THE SANGGUNIANG BARANGAY OF BARANGAY CURVA, ORMOC CITY, ENTITLED: " AN ORDINANCE IMPOSING FEES ON THE ISSUANCE OF BARANGAY BUSINESS CLEARANCES, BARANGAY BUSINESS TAX, CERTIFICATIONS, PERMITS AND OTHER CHARGES" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION.

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received a copy of Tax Ordinance No. 2015-001 of the Sangguniang Barangay of Barangay Curva, this City, entitled: " AN ORDINANCE IMPOSING FEES ON THE ISSUANCE OF BARANGAY BUSINESS CLEARANCES, BARANGAY BUSINESS TAX, CERTIFICATIONS, PERMITS AND OTHER CHARGES", copies of the Ordinance and its corresponding attachments are hereto attached and made integral parts hereof;

WHEREAS, the subject Ordinance was submitted to this august Body pursuant to its review powers over enacted barangay ordinances of all barangays within its territorial jurisdiction as provided for in Section 57 of the Local Government Code of 1991 (LGC) in order to find out if the Tax Ordinance under review is in conformity with existing laws and city ordinances and within the scope of the taxing powers of the Barangay concerned;

WHEREAS, the Ordinance is anchored on the concerned Barangay's vested revenue-raising authority under Sections 152 and 153 of the LGC, and its inherent power to formulate and create its own sources of revenue through, among others, the levying of barangay business tax and the imposition of fees and charges for the issuance of barangay clearances and certifications, permits and other services, in order to raise the much needed barangay funds which will accelerate economic development and upgrade the quality of life for the people of the Barangay, not to mention promote the efficient and effective delivery of basic services;

WHEREAS, this Sanggunian, in the exercise of its review powers, and after thorough examination of the aforesaid Tax Ordinance, finds that the same is indeed in conformity and compliance with existing applicable laws and city ordinances, including sufficient compliance of the requirement for the conduct of a public hearing required of tax ordinances in accordance with the LGC's Implementing Rules and Regulations, which in this particular setting was conducted on October 12, 2014 at the Barangay covered court, and further, deems that its enactment is most beneficial to the concerned Barangay, particularly in raising revenues for more efficient and effective delivery of public service to its constituents, and thus, rendering it most deserving of this august Body's approval and its interposition of no objection to its implementation;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Rolando M. Villasencio, Tomas R. Serafica, Ruben R. Capahi, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. 
