RESOLUTION NO. 2015-116

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), THE OXFAM GB - WESTERN LEYTE PROGRAM, REPRESENTED BY ITS TRANSITION TEAM LEADER, MERCY ALIDRI, THE QUEZON JR. UNITED FARMERS' ASSOCIATION (QUEUFA), AND THE BARANGAY COUNCIL OF QUEZON JR., BOTH REPRESENTED BY QUEUFA PRESIDENT AND QUEZON JR. BRGY. CHAIRMAN, JULIETO R. YAHOT, FOR THE HAND OVER OF THE CONSTRUCTED GENDER POINT FACILITY AT BARANGAY QUEZON JR., ORMOC CITY.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated May 4, 2015 requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to enter and sign the MOU by and between the Local Government Unit of Ormoc (LGU-ORMOC), the OXFAM GB - Western Leyte Program, represented by its Transition Team Leader, Mercy Alidri, the Quezon Jr. United Farmers' Association (QUEUFA) and the Barangay Council of Quezon Jr., both represented by QUEUFA President & Barangay Chairman, Juliето R. Yahot, for the hand over of the constructed Gender Point Facility at Barangay Quezon Jr., Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, OXFAM GB is an International Non Government Organization which focuses on among others, increasing opportunities for women and gender equality within the barangays;

WHEREAS, QUEUFA is a farmers organization which is based in Barangay Quezon Jr., Ormoc City;

WHEREAS, OXFAM GB, in support of its concern of empowering the women, has constructed a Gender Point Building at Barangay Quezon Jr., a Care Work Facility which is a support infrastructure for livelihood projects and gender-related concerns of the women's organization, QUEUFA, with a Gender Based Violence (GBV) counseling room, child-minding corner/children's corner, conference area, and has two toilets, with a floor area of 6 x 10 meters;

WHEREAS, LGU-Ormoc expresses its willingness to support the Gender Point Building and to this effect has waived the corresponding building permit fees relative to the building construction and assigned the City Engineering Office for the consultation and supervision of the construction, as well as the City Social Welfare and Development Office in supporting the women's concerns of QUEUFA and other women clientele in Quezon Jr.;

WHEREAS, the Barangay Council of Quezon Jr. also expresses its willingness and commitment of the project by issuing a Barangay Resolution accepting the project and has assumed the function of monitoring the construction of the Gender Point Building as well as mobilized its citizenry to support the construction works with OXFAM leading the implementation thereof until its completion;

WHEREAS, QUEUFA as the primary beneficiary of the project has signified great interest, and likewise actively participated in voluntary and miscellaneous support works for the speedy completion of the project;

WHEREAS, OXFAM, LGU-Ormoc, BC-Quezon Jr., and QUEUFA, which are all inspired by a common objective of gender justice and equality, collaborated with each other for the successful implementation of the Gender Point Building construction which commenced last January 2015 and was completed on March 13, 2015;

WHEREAS, with the completion of the subject Gender Point Building, OXFAM - GB is now ready to hand-over the building to the identified beneficiaries subject to the terms and conditions provided in the MOU;

WHEREAS, the parties thereto have agreed to perform committedly their therein described roles and responsibilities, with the goal of maximizing productivity and usage of the Gender Point Facility as well as the efficient maintenance and safekeeping of subject building, and this Sanggunian finds, after close and thorough review of the MOU, that it is indeed extremely beneficial specifically to the women of Barangay Quezon Jr., and so therefore, most deserving of this august body's utmost support and favorable consideration with the august Body, additionally, taking this special occasion to express its utmost recognition and appreciation of OXFAM's profound magnanimity in coming to Ormoc's aid and assistance in its recovery and rehabilitation endeavors post-Yolanda;

WHEREFORE, on joint motion of Honorable SP Member Honorable Benjamin S. Pongos Jr., Chairman Committee on Laws and Ordinances and Honorable SP Member, Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries, severally seconded by Honorable SP Members Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerado S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
