RESOLUTION NO. 2015-119

*A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR, HONORABLE EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY THE REGIONAL DIRECTOR OF FIELD OFFICE VIII, MR. NESTOR B. RAMOS, FOR THE IMPLEMENTATION OF DSWD'S SOCIAL PROTECTION PROGRAMS/PROJECTS OR ACTIVITIES.*

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of a 3<sup>rd</sup> indorsement dated June 5, 2015 from the Honorable Ormoc City Mayor Edward C. Codilla requesting for the passage of a resolution authorizing him to enter into and sign the Memorandum of Agreement (MOA) by and between DSWD and the City of Ormoc for the implementation of DSWD's Social Protection Programs/Projects or Activities;

WHEREAS, said MOA aims to establish a partnership between DSWD and this City for the development and implementation of social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in our City;

WHEREAS, these Social Protection Programs/Projects involve: the Pantawid Pamilyang Pilipino Program (4Ps), which provides conditional cash grants to the poorest of the poor, to improve the health, nutrition, and the education of children; the Social Pension for Indigent Senior Citizens, which provides monthly pension to our eligible indigent senior citizens; the Sustainable Livelihood Program, which seeks to improve the socio-economic status of the people; the Cash for Building Livelihood Assets, formerly known as cash-for-work program which aims to rebuild the livelihood of the displaced families; and, other social protection programs and projects of DSWD;

WHEREAS, under the aforesaid MOA, any DSWD Social Protection Program, Project or Activity (PPA) shall be established through the execution of Specific Implementation Agreements (SIA) which shall, in turn, be authorized in writing by each party's authorized representative, after which each SIA shall form part of said MOA;

WHEREAS, the PPAs covered by specific SIAs under the abovementioned agreement shall be subject to periodic reviews by both parties;

WHEREAS, this Sanggunian, after thorough and extensive review of the MOA, finds that it is not inconsistent with law, public policy and public morals and that the DSWD PPAs covered thereon are additionally determined to be hugely beneficial and advantageous to the intended beneficiaries, who mostly come from the marginalized and vulnerable sectors of society;

WHEFORE, on joint motion of the Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family and Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Ruben R. Capahi, Antonio M. Codilla, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
