RESOLUTION NO. 2015-121

A RESOLUTION INTERPOSING NO OBJECTION TO THE REQUEST OF THE SANGGUNIANG PAMBARANGAY OF DISTRICT XII, ORMOC CITY, "TO USE THE AREA ADJOINING THE MULTI-PURPOSE BARANGAY HALL TO CONSTRUCT A CONCRETE PAVEMENT", AND RECOMMENDING TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA THAT THE AFOREMENTIONED REQUEST BE GRANTED, SUBJECT TO THE FOLLOWING CONDITIONS, TO WIT: (1) NO PERMANENT VERTICAL STRUCTURES BE ESTABLISHED IN THE FUTURE; (2) COST OF THE PROJECT BE BORNE SOLELY BY BRGY. DISTRICT XII; (3) THAT IN THE EVENT, THE AREA IS NEEDED BY THE CITY GOVERNMENT OF ORMOC, THE SAME SHALL BE VACATED BY BRGY. DISTRICT XII AND THE CITY GOVERNMENT OF ORMOC HAS NO OBLIGATION WHATSOEVER TO REIMBURSE THE COST OF THE IMPROVEMENT, THEREON.

WHEREAS, this 13th Sangguniang Panlungsod ng Ormoc received a Resolution No. 23, Series of 2015 of the Sangguniang Pambarangay of District XII, Ormoc City, entitled: "A RESOLUTION ASKING THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY, THROUGH THE HONORABLE CITY MAYOR EDWARD C. CODILLA, A PERMISSION TO USE THE AREA ADJOINING THE MULTI-PURPOSE BARANGAY HALL TO CONSTRUCT A CONCRETE PAVEMENT" which resolution was indorsed to this Sanggunian for appropriate action; (Copy of aforementioned resolution with attachment is hereto attached for ready reference and considered an integral part of this resolution);

WHEREAS, prior to the endorsement of subject resolution to this august Body, the same was endorsed by City Legal Officer, Atty. Ivan Verallo to CPDO, Engr. Raoul Cam for his comment and recommendation, and in reply thereto, Engr. Cam commented "that the construction of concrete pavement may be allowed in the area, provided, that no permanent vertical structures be established in the future", and upon receipt thereof, Atty. Verallo made an indorsement to the Honorable City Mayor Edward C. Codilla, which in part states: "this office interpose no legal objections to the implementation of the thereof. (sic) Hence, the idea is for the City Mayor to endorse the request to the 13th Sangguniang Panlungsod ng Ormoc for appropriate action.";

WHEREAS, the Committee on Public Properties to which subject resolution of Brgy. District XII, was referred to, held a committee meeting on June 18, 2015 which decided to grant/approve the request of said Barangay, subject to the conditions aforestated in the title of this resolution; in the presence of some Barangay Officials of District XII, headed by its Punong Barangay, Hon. Jose Maria Miguel P. Aviles;

WHEREAS, the area subject of the request of Brgy. Dist. XII contains 185 sq. meters;

FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by Honorable SP Members Vincent L. Rama, John Eulalio Nepomuceno O. Aparis II, Eusebio Garardo S. Penserga and Tomas R. Serafica; be it -

RESOLVED, AS IT IS HEREBY RESOLVED to pass and adopt a resolution INTERPOSING NO OBJECTION TO THE REQUEST OF THE SANGGUNIANG PAMBARANGAY OF DISTRICT XII, ORMOC CITY "TO USE THE AREA ADJOINING THE MULTI-PURPOSE BARANGAY HALL TO CONSTRUCT A CONCRETE PAVEMENT", AND RECOMMENDING TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA THAT THE AFOREMENTIONED REQUEST BE GRANTED, SUBJECT TO THE FOLLOWING CONDITIONS, TO WIT: (1) NO PERMANENT VERTICAL STRUCTURES BE ESTABLISHED IN THE FUTURE; (2) COST OF THE PROJECT BE BORNE SOLELY BY BRGY. DISTRICT XII; (3) THAT IN THE EVENT, THE AREA IS NEEDED BY THE CITY GOVERNMENT OF ORMOC, THE SAME SHALL BE VACATED BY BRGY. DISTRICT XII AND THE CITY GOVERNMENT OF ORMOC HAS NO OBLIGATION WHATSOEVER TO REIMBURSE THE COST OF THE IMPROVEMENT, THEREON;
