FOLLOWING CIVIL SOCIETY ORGANIZATIONS (CSOs), TO  
WIT:

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received the application of Uptown Village Homeowners Association, Inc. (UVHOAI) and Ormoc - Puertobello and Merida Multicab Operators and Drivers Association (OPMMODA), both are Civil Society Organizations (CSOs) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation for membership in Local Special Bodies by any organization shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned applications, finds that the same are in order and the purpose of the sought accreditation is for the realization of the respective organization's noble intention to be able to assist and work hand in hand with the LGU in various areas of concern with the end goal of efficiently providing the people the much needed public services;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by Honorable SP Member Eusebio Gerardo S.
