RESOLUTION NO. 2015-128

A RESOLUTION DECLARING THAT TAX ORDINANCE NO. 15-001 OF THE SANGGUNIANG BARANGAY OF BARANGAY CABAON-AN, ORMOC CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES ON BUSINESSES, ACTIVITIES AND BILLBOARDS IN BARANGAY CABAON-AN, ORMOC CITY" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION.

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received a copy of Tax Ordinance No. 15-001 of the Sangguniang Barangay of Barangay Cabaon-an, this City, entitled: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES ON BUSINESSES, ACTIVITIES AND BILLBOARDS IN BARANGAY CABAON-AN, ORMOC CITY", copies of the Ordinance and its corresponding attachments are hereto attached and made integral parts hereof;

WHEREAS, the subject Ordinance was submitted to this august Body pursuant to its review powers over enacted barangay ordinances of all barangays within its territorial jurisdiction as provided for in Section 57 of Republic Act No. 7169, otherwise known as the Local Government Code of 1991 (LGC) in order to determine if the Ordinance under review is in conformity with existing laws and city ordinances and is within the scope of the taxing powers of the Barangay concerned;

WHEREAS, the Ordinance is anchored on the concerned Barangay's vested revenue-raising authority under Sections 152 and 153 of the LGC, and its inherent power to formulate and create its own sources of revenue through, among others, the levying of barangay business tax, the imposition of fees and charges for the issuance of barangay clearances and certifications, permits and other services, including the imposition of charges for the display and maintenance of billboards, signboards, neon signs, and outdoor advertisements, in order to raise the much needed barangay funds which will accelerate economic development, upgrade the quality of life for the people of the Barangay, and promote the efficient and effective delivery of basic services;

WHEREAS, this Sanggunian, in the exercise of its review powers, and after thorough examination of the aforesaid Ordinance, finds that: the same is indeed in conformity and compliance with existing applicable laws and city ordinances; the taxes, fees and charges levied thereon are just, lawful and reasonable; the required public hearing which was conducted on March 3, 2015 in the Barangay's basketball court was in accordance with the LGC's Implementing Rules and Regulations; and, that finally, the Ordinance's enactment will be most beneficial to the concerned Barangay, particularly in raising revenues for more efficient and effective delivery of public service to its constituents, rendering the Ordinance, therefore, most deserving of this august Body's approval and its interposition of no objection to its implementation;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Vincent L. Rama, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION DECLARING THAT TAX ORDINANCE NO. 15-001 OF THE SANGGUNIANG BARANGAY OF BARANGAY CABAON-AN, ORMOC CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES ON BUSINESSES, ACTIVITIES AND BILLBOARDS IN BARANGAY CABAON-AN, ORMOC CITY" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND ORDINANCES, AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION;
