RESOLUTION NO. 2015-131

A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC OF THE PHILIPPINE NETWORK FOR RURAL DEMOCRATIZATION AND DEVELOPMENT, INC. (PHILNET INC.) IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received the application of Philippine Network for Rural Democratization and Development (PhilNet Inc.) , located at 101 Bloomfield Subdivision, Brgy. San Isidro, Ormoc City, a Civil Society Organization (CSO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned application, finds that the same is in order, and the purpose of the sought accreditation is for the subject organization to implement gender responsive programs and services in collaboration with LGU-Ormoc that will enable partner Marginalized Rural Sector and Peoples (MRSP) attain self-determining disaster-resilient rural communities in Ormoc City through direct and sustained participation in the Rural Democratization and Development (RDD) processes;
