RESOLUTION NO. 2015-141

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
TO ENTER AND SIGN THE ADDENDUM TO THE  
MEMORANDUM OF AGREEMENT BY AND BETWEEN THE  
WORLD VISION DEVELOPMENT FOUNDATION,  
REPRESENTED BY ITS TYPHOON HAIYAN RESPONSE  
DIRECTOR, MS. DINEEN TUPA AND THE CITY  
GOVERNMENT OF ORMOC, REPRESENTED BY THE  
HONORABLE EDWARD C. CODILLA, FOR THE  
REHABILITATION PHASE ON LIVELIHOODS, DISASTER  
RISK REDUCTION (DRR) AND ADVOCACY ACTIVITIES.

WHEREAS, this 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc is in receipt of a 2<sup>nd</sup> indorsement dated June 25, 2015 from the Office of the City Mayor requesting this august Body to pass a resolution giving the Honorable Mayor authority in behalf of the City of Ormoc to sign and enter into an Extension of Memorandum of Agreement (MOA) with the World Vision Development Foundation, Inc.;

WHEREAS, it can be remembered that this august Body has carried unanimously and passed Resolution No. 2014-052 on March 27, 2014 which authorized the Honorable City Mayor to enter into and sign a MOA for and in behalf of the City Government of Ormoc with the World Vision Development Foundation for a strategic partnership as one of the key to effectively implement and sustain development intervention in Ormoc City;

WHEREAS, the MOA described in the next preceding clause has already concluded on December 31, 2014;

WHEREAS, despite the expiration of the MOA, World Vision, however, is not yet done helping its intended beneficiaries in the 10 remaining, out of 17 barangays, which were selected as priority areas for the implementation of said development intervention in the City;

WHEREAS, the remaining barangays shall only be the subject of the current rehabilitation phase of the project involving Livelihood, Disaster Risk Reduction (DRR) and Advocacy activities projected to be accomplished by the end of the year 2015;

WHEREAS, there is a need to have the existing MOA extended until December 31, 2015;

WHEREAS, this august Body believes that the extension of the MOA is highly advantageous and favorable to its intended beneficiaries in the selected priority areas of this City;

WHEREFORE, foregoing premises considered, on joint-motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family and Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, John Eulalio Nepomuceno O. Aparis II, Eusebio Gerardo S. Penserga and Mariano Y. Corro; be it

DINEEN TUPA AND THE CITY GOVERNMENT OF ORMOC, REPRESENTED BY THE HONORABLE EDWARD C. CODILLA, FOR THE REHABILITATION PHASE ON LIVELIHOODS, DISASTER RISK REDUCTION (DRR) AND ADVOCACY ACTIVITIES;
