RESOLUTION NO. 2015-145

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A LETTER OF AGREEMENT (LOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA, CESO III, FOR THE PROVISION OF FARM TOOLS AND PLANT MATERIALS FOR THE PROJECT ENTITLED: ESTABLISHMENT OF THE MULTIPLICATION OF QUALITY PLANTING MATERIALS (MULTIPLIER FARM) IN SUPPORT OF THE REHABILITATION ASSISTANCE ON YOLANDA.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated July 13, 2015 relative to the preceding Indorsement from the City Legal Officer, Ivan B. Verallo, recommending for the passage of a resolution authorizing the Hon. City Mayor to sign the Letter of Agreement (LOA) for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Department of Agriculture Regional Field Office No. 8 (DA-RFO 8), represented by its Regional Executive Director, Leo P. Cañeda, CESO III, for the provision of Farm Tools and Plant Materials for the project entitled: establishment of the Multiplication of Quality Planting Materials (Multiplier Farm) in Support of the Rehabilitation Assistance on Yolanda considering that there is no legal impediment to implement the same, a photocopy of the final LOA is hereto attached and made an integral part hereof;

WHEREAS, the DA-RFO8, had proposed the establishment of "Multiplier Farms" in each municipality hardest-hit by Typhoon Yolanda, as part of the rehabilitation plan of building back better farming communities in typhoon-affected areas in the region and provinces;

WHEREAS, Multiplier Farms are envisioned to serve as a sustainable source of quality materials and/or animal stock for distribution to qualified beneficiaries in cities and municipalities;

WHEREAS, the provision of farm tools, as well as the provision of planting materials following the multiplier farm approach are initially provided to all the qualified farmer-beneficiaries prepared by DA Region 8 and validated by the DA area focal, in coordination with the MAO/PA and the MAFC of PAFC ;

WHEREAS, LGU-ORMOC signified its intention to be one of the recipients of Farm Tools and Planting Materials from DA-RFO8 under the subject Multiplier Farm Program and, the DA, through its representative evaluated the capability of LGU-Ormoc and found it to be qualified as a recipient of the aforesaid farm tools and planting materials based on the criteria set for the establishment of the said program;

WHEREAS, both parties are mutually committed in collaborating for the successful establishment of the Multiplication of Quality Planting Materials (Multiplier Farm) in Ormoc City as well as the provision of farm tools that goes along with this program under the rehabilitation assistance on Yolanda, subject to the specific roles and commitments of the parties stipulated in the LOA;

WHEREAS, this Sanggunian finds, after close and thorough review of the subject LOA, that it is extremely beneficial to the benefitted local farmers, and the same will indeed immensely benefit the underprivileged, and therefore, is most deserving of its prompt favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries and Honorable Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Pensergera, John Eulalio Nepomoceno O. Aparis II and Mariano Y. Corro; be it


RESOLVED, FURTHER, that a copy of the final and notarized Letter of Agreement (LOA) be furnished to this Sanggunian for its information and files;
