RESOLUTION NO 2015-146

*A RESOLUTION REQUESTING THE BUREAU OF FISHERIES
AND AQUATIC RESOURCES (BFAR) VIII OFFICE TO GIVE
ONE (1) UNIT OF FORTY – FOOTER PATROL BOAT WITH
TWIN ENGINE FOR THE BANTAY DAGAT OF ORMOC.*

WHEREAS, pursuant to R.A. 8550 otherwise known as "The Fisheries Code of the Philippines", the Bantay Dagat, under the City Fisheries and Aquatic Resources Management Council (CFARMC), is created carrying with it the function to assist in the enforcement of fishery laws, rules and regulations in concerned municipal waters and advice the concerned Sangguniang Panlungsod on fishery matters through its Committee on Fisheries;

WHEREAS, the Bantay Dagat cannot effectively perform the above function with regard to the enforcement of fishery laws, rules and regulations due to the inadequacy of patrol boats to be used for the daily patrol operation especially during night time;

WHEREAS, the present patrol boats used by the Bantay Dagat are small and has been used beyond its prime and it having many holes on each side, is among other challenges;

WHEREAS, the Bantay Dagat is in need of a forty-footer patrol boat with twin engine in order for them to effectively pursue the abovesited function;

WHEREAS, said forty-footer patrol boat can also be used as a rescue boat in times of tragedy like the recent sea mishap of M/B Kim Nirvana which befell our city;

WHEREAS, this august body is in receipt of Resolution No. 3, series of 2015 issued jointly by the City Fisheries and Aquatic Resources Management Council and Ormoc Fish Warden (OFW) requesting the 13th Sangguniang Panlungsod ng Ormoc, thru Hon. Leo Carmelo L. Locsin, Jr. to pass a resolution requesting the Bureau of Fisheries and Aquatic Resources VIII Office to bestow one (1) unit of forty-footer patrol boat with twin engine for the Bantay Dagat of Ormoc;

WHEREAS, this august Body finds said request as embodied in the above resolution to be meritorious;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries, severally seconded by Honorable SP Members Mario M. Rodriguez, Antonio M. Codilla, Pedro Godiardo P. Ebcas, Vincent L. Rama, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


