RESOLUTION NO. 2015-152

A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR, HONORABLE EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE HELP - HILFE ZUR SEBSTHILFE E.V. REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER CONCERNING THE PRE-POSITIONING OF RELIEF ITEMS APPROXIMATELY AMOUNTING UP TO PHP 9,000,000.00.

WHEREAS, this 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc is in receipt of an indorsement from the Office of the City Mayor requesting this august Body to pass a resolution giving authority to the Honorable City Mayor Edward C. Codilla, to sign and enter into a Memorandum of Understanding (MOU) by and between the City of Ormoc and HELP - Hilfe zur Selbsthilfe e.V.;

WHEREAS, the said MOU pertains to the Pre-positioning of relief items approximately amounting up to Php 9,000,000.00 in preparation for future disasters to happen in any location in the Philippines;

WHEREAS, under the abovementioned MOU, the City warrants to store all relief items in a suitable, safe and clean storage facility on its expense for up to Twenty Four (24) months or until HELP ends its humanitarian program in the Philippines, whichever comes first;

WHEREAS, while the City Social Welfare and Development Office (CSWDO) may recommend which barangay/s may be the recipient/s of the relief items, HELP has the exclusive authority to select the direct beneficiaries of the same;

WHEREAS, the City's designated focal person shall work hand in hand with HELP during the delivery and storage of all relief items and visibility materials;

WHEREAS, in consonance with the City's commitment under this MOU, the City exhibits support to take part and share HELP's humanitarian advocacy, in aid of those other cities or municipalities which might be affected with calamity;

WHEREAS, HELP will donate the said relief items to the City at the end of Twenty Four (24) months or after HELP ends its humanitarian aid program in the Philippines, whichever comes first, and such relief items may then be utilized by the City for relief operations without executing another MOU;

WHEREAS, since the City is the prioritized recipient of said relief items upon the occurrence of disasters, this MOU is deemed greatly beneficial to the City's constituents;

WHEREFORE, foregoing premises considered, on joint motion of Honorable SP Member Mariano Y. Corro, Vice-chairman, Committee on Laws & Ordinances, and Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, severally seconded by Honorable SP Members Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Pensenga and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR, HONORABLE EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE HELP - HILFE ZUR SEBSTHILFE E.V. REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER CONCERNING THE PRE-POSITIONING OF RELIEF ITEMS APPROXIMATELY AMOUNTING UP TO PHP 9,000,000.00;
