A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF PARTNERSHIP AGREEMENT (MOPA). FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE PHILIPPINE RED CROSS (PRC), REPRESENTED BY ITS SECRETARY GENERAL GWENDOLYW PANG, FOR THE IMPLEMENTATION OF TYPHOON HAIYAN SHELTER AND WASH RECOVERY PROJECT IN ORMOC SUPPORTED BY THE SWISS RED CROSS.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated July 30, 2015 requesting therein for the passage of a resolution granting authority to the Honorable City Mayor Edward C. Codilla, to enter into and sign the Memorandum of Partnership Agreement (MOPA) by and between the LGU – Ormoc and the PRC, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, PRC is an independent humanitarian organization affiliated with the International Federation of the Red Cross and Red Crescent committed to provide quality life-saving services that protect the life and dignity especially of indigent Filipinos in vulnerable situations;

WHEREAS, anent to that, PRC is currently providing assistance to typhoon Haiyan affected families in nine (9) Barangays in Ormoc City, namely: Mahayahay, Biliboy, Cabintan, Quezon Jr., Bayog, RM Tan, Magaswe, Mas-in and Boroc, including the construction of Six Hundred Eighty One (681) disaster-resilient homes with comfort rooms and through Eight Hundred Seventeen (817) repair assistance packages, which implementation thereof is the main object of this MOPA;

WHEREAS, the said projects will be undertaken through the funding support of the Swiss Red Cross, and its implementation is geared towards reducing the vulnerability to typhoons of the most affected families in the aforementioned Barangays by providing and improving their capacities in WASH and Habitability in line with the National Recovery Plan of the Philippine Government;

WHEREAS, the aforesaid MOPA specifies that the PRC will establish a Red Cross Barangay Recovery Committee in each of the above-stated Barangays in monitoring and decision making of the project which shall be composed of focal representatives of the barangay government, different associations, as well as the affected families in support for the implementation;

WHEREAS, the LGU-Ormoc commits itself thru involvement and cooperation to support regular programs of the PRC in the City as contained in the MOPA as well as to offer support to the Barangays in all aspects, including the assignment of focal persons, for the effective and successful implementation of the said projects;

WHEREAS, the above parties have entered into this partnership with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon and that are directed towards achieving an effective implementation of Typhoon Haiyan Shelter and WASH recovery projects in Ormoc City;

WHEREAS, this august Body, after thorough review and examination of the MOPA, finds that the projects object of the MOPA indeed significantly assist the benefitted typhoon-affected communities in Ormoc City in its recovery and development efforts, and for which reason, this august Body grants its full support and affirmative action to the same, along with its conveyance of utmost appreciation and gratitude to the PRC for its lofty and humanitarian acts of tremendous aid and assistance to the City in her recovery and development efforts;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, severally seconded by Honorable SP Members Rolando M. Villasencio, Tomas R. Serafica, Mario M. Rodriguez, Ruben R. Capahi, Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
