RESOLUTION REQUESTING THE MARITIME *INDUSTRY* AUTHORITY (MARINA) TO ACT FAVORABLY APPLICATION OF LITE SHIPPING CORPORATION ON THE (LSC) TO SERVE THE ROUTE OF QUANO, MANDAUE CITY, CEBU - PUNTA, CITY, LEYTE AND VICE VERSA.

WHEREAS, this Thirteenth Sanggunian received a communication dated July 2015, relative to the request of Mr. Neil P. Pingkian, Lite Shipping Corporation (LSC) AVP - Operations, for an endorsement from this august Body in support to their application with MARINA to serve the route Ouano, Mandaue City, Cebu -Punta, Ormoc City, Leyte and vice versa;

WHEREAS, Ormoc City is a developing and growing city, and considered as the gateway to the neighboring provinces, cities and municipalities with the sea transport taking an important part in the envisioned economic growth and development of its tourism, since it accommodates a huge number of commuters, tourists and businessmen coming in and going out of the city;

WHEREAS, LSC had been serving the Ormoc City route since 2004 and considering the increasing demand for a reliable and safe domestic shipping service for passengers and cargoes, it intends to establish a new route covering from Ouano, Mandaue City, Cebu - Punta, Ormoc City and vice versa to dock specifically at the GGC Private Port;

WHEARAS, safety and quality of service to the riding public are paramount considerations of the company in order to meet the needs of commuting public in accordance with the standards of common carriers;

WHEREAS, this august Body believes that said request is reasonable and beneficial to the riding public and promotes economic growth as well hence, the same deserves to be accorded due course of action;
