## RESOLUTION 2015-170

RESOLVITON GRANTING AUTHORITY TO THE HONORABLE CITY MAXOR FOWARD C. CODILLA TO ENTER INTO AND GN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGV-CRMOC) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA, CESO III, FOR THE IMPLEMENTATION OF THE ORGANIC AGRICULTURE PROJECT ENTITLED: "PROVISION OF INPUTS FOR ORGANIC VEGETABLE PRODUCTION AND RAISING OF SMALL RUMINANTS" TO BE FUNDED FROM THE LGU-ORMOC CASH AWARD (GRANT) AMOUNTING TO THREE HUNDRED THOUSAND PESOS ONLY (P 300,000.00) AS THE WINNER UNDER THE CITY CATEGORY DURING THE REGIONAL AGRICULTURE ACHIEVERS AWARD LAST 2014 AS THE BEST LGU, FOR ORGANIC AGRICULTURE IMPLEMENTATION.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated August 13, 2015 requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to sign and enter into a Memorandum of Agreement (MOA) by and between the Department of Agriculture Regional Field Office No. 8 (DA-RFO 8) and the City Government of Ormoc, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA refers to the implementation of the Organic Agriculture Project referred to as "Provision of Inputs for Organic Vegetable Production and Raising of Small Ruminants" geared towards the promotion and development of Organic Agriculture in the Philippines;

WHEREAS, LGU Ormoc through the City Agriculture Office, has been declared as the "Best LGU for Organic Agriculture Implementation" under the City Category by the Department of Agriculture during the 2014 Regional Agriculture Achievers Award and was awarded with a cash prize of Three Hundred Thousand Pesos (P300,000.00) as grant to fund an LGU project related to organic agriculture;

WHEREAS, in order to facilitate the release of the said award the City Agriculture Office submitted a proposal on the project to be funded thereof and the same was duly considered and approved by the DA-RFO 8 for implementation;

WHEREAS, the members of both the sustainable Organic Farming Advocates of Ormoc City (SOFAOC) who are into organic vegetable production and the Independent Component City Agriculture and Fishery Council (ICCAFC) who desires to raise small ruminants will be the target beneficiaries of the proposed project;

WHEREAS, both parties are mutually committed in collaborating for the successful implementation of the aforementioned organic agriculture project, subject to the specific roles and commitments of the parties stipulated in the MOA;

WHEREAS, this Sanggunian finds, after close and thorough review of the subject MOA, that it will greatly help the local farmers specifically those engaged in organic vegetable farming and raising of small ruminants with the end goal of maximizing their production to attain self sufficiency, food security and sustainability, and therefore, is most deserving of its prompt favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries and Honorable Mariano Y. Corro, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas and Eusebio Gerardo S. Penserga; be it
