A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE
CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND
SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND
ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC
(LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE
REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8),
REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR,
LEO P. CAÑEDA, CESO III, FOR THE PROVISION OF ONE
(1) UNIT CASSAVA GRANULATOR CUM SHREDDER AS
GRANT UNDER THE AGRI - PINOY CORN
PROGRAM/CASSAVA PROJECT OF THE DEPARTMENT OF
AGRICULTURE (DA).

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated August 24, 2015 pertaining to the preceding Indorsement from the City Agriculturist, Joseph C. Cortes, recommending for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to sign the MOA by and between the DA-RFO 8, and LGU-Ormoc, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA deals with the provision of one (1) unit Cassava Granulator cum Shredder by the DA-RFO 8 to LGU - Ormoc through the City Agriculture Office;

WHEREAS, the DA through its Regional Field Office 8, is in pursuit of poverty alleviation in the agricultural sector and food security hence, implementing the Agri - Pinoy Corn Program/Cassava Project, as envisioned under Republic Act 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1995;

WHEREAS, one of the components of said program is the provision of Cassava Granulator cum Shredder to the qualified farmer organizations and/or LGUs in order to help in modernizing the farm operations through mechanized farming activities that contributes to the production of cassava in the localities;

WHEREAS, LGU-ORMOC signified its intention to be one of the recipients of one (1) unit Cassava Granulator cum Shredder from DA-RFO8 for the implementation of the Agri – Pinoy Corn Program/Cassava Project with the aim of transforming the agriculture sector from a resourced-based to a technology based industry;

WHEREAS, the one (1) unit Cassava Granulator cum Shredder will be purchased by the DA-RFO 8, charge to the Agri Pinoy Corn Program/Cassava Project Fund amounting to Sixty Thousand Seven Hundred Pesos Only (P60,700.00);

WHEREAS, the parties thereto have agreed to perform committedly their therein described obligations and responsibilities towards the achievement and implementation of the MOA, and this Sanggunian finds, after close and thorough review of the same, that it is extremely beneficial to the qualified Ormoc City Cassava farmer – beneficiaries considering that it will greatly help improve the farming communities by increasing their productivity and profitability, and so therefore, is most worthy of this august Body's prompt favorable consideration and support;

WHEREFORE, on joint motion of Honorable SP Member Tomas R. Serafica., Chairman, Committee on Agriculture & Fisheries and Mariano Y. Corro, Vice-Chairman, Committee on Laws & Ordinances, severally seconded by Honorable SP Members Rolando M. Villasencio, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga and John Eulalio Nepomuceno O. Aparis II; be it


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be furnished to this Sanggunian for its information and files;
