A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE COLLECTION AND REMITTANCE AGREEMENT (CARA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), REPRESENTED BY ITS PRESIDENT AND CEO, ATTY. ALEXANDER A. PADILLA, FOR THE COLLECTION AND REMITTANCE OF PHILHEALTH PREMIUM CONTRIBUTIONS.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated August 6, 2015 requesting therein for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to enter and sign the CARA by and between the LGU-ORMOC, with PHILHEALTH in connection with the collection and remittance of PHILHEALTH Premium Contributions, a photocopy of the final CARA is hereto attached and made an integral part hereof;

WHEREAS, PHILHEALTH is mandated to provide social health insurance coverage to all Filipinos and further assumed the responsibility of administering the National Health Insurance Program (NHIP) for government and private sector employees, Self-employed Professionals, individually paying program, and sponsored sector program as well as the new members;

WHEREAS, anent thereto, PHILHEALTH is authorized to formulate and implement guidelines on contributions and benefits, including the payment and collection of its Premium Contribution from its members;

WHEREAS, Section 13 of RA 7875 otherwise known as the Implementing Rules and Regulations of the National Health Insurance Act, as amended by RA 9241 provides that "remittance of premium contribution shall be made to PhilHealth Offices or to any of the accredited collecting agents";

WHEREAS, PHILHEALTH, in pursuit of its mandate to provide social health insurance to the public, has accredited LGU-Ormoc as one of its collecting agents to provide the collection-remittance service for the NHIP premiums from Philhealth members for more convenience and accessibility to the paying members and employers;

WHEREAS, LGU-Ormoc commits its willingness to act as collecting agent for the collection of Philhealth Premium Contributions pursuant to its new guidelines as provided in Philhealth Circular No. 08. S 2009;

WHEREAS, the abovementioned parties have faithfully entered into this undertaking with the general aim of achieving an effective implementation of the Collection and Remittance Agreement subject to their corresponding covenants and obligations stipulated in the CARA and its implementing Guidelines;

WHEREAS, this august Body, after thoroughly reviewing the CARA and conducting a committee meeting regarding the matter, firmly concludes that the objective of the CARA is indeed extremely beneficial to the paying public and thus, absolutely deserves this august Body's full support and affirmative action;
