## RESOLUTION NO. 2015-177

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FOWARD C. CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION (DOD) MADE AND EXECUTED BY EDWIN CON-DI AND SHERYL CON-UI AS DONORS OF A PORTION OF A PARCEL OF LAND LOCATED AT BARANGAY LILO-AN, ORMOC CITY, FOR ROAD RIGHT OF WAY PURPOSE, IN FAVOR OF THE CITY GOVERNMENT OF ORMOC AS DONEE.

WHEREAS, this Thirteenth Sanggunian received an Urgent indorsement dated August 24, 2015 from the Office of City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to accept and sign the Deed of Donation by and between Edwin Con-ui and Sheryl Con-ui and the City Government of Ormoc, a photocopy of the final Deed of Donation of which is hereto attached and made an integral part hereof;

WHEREAS, the DONORS are the true registered owners of certain parcel of land located at Barangay Lilo-an, this city, which is particularly described as Lot No. 11535-D-1, covered by Certificate of Title No. 53464 and Tax Declaration No. 00946 with a portion of said parcel with Four Hundred Twenty-Two (422) Square Meters to be the subject of this donation;

WHEREAS, as provided for in the Deed of Donation, the aforementioned parcel of land donated shall be utilized only as a road right of way by the Donee and not for any other purpose it so desires;

WHEREAS, the DONEE expresses its profound gratitude for this manifestation of affection and act of liberality and generosity on the part of the DONORS and thereby accepts the foregoing donation;

WHEREAS, the subject DOD has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, and it was his findings that there is no legal impediment for the execution of the same and therefore recommended for the passage of a resolution authorizing the City Mayor to sign the Deed of Donation;

WHEREAS, this august body finds that all the provisions in the Deed of Donation are just and reasonable, the donation as well is deemed beneficial and advantageous to the city, hence, the requested authority of the Honorable City Mayor to accept and sign the same deserves to be accorded the necessary course of action;

WHEREFORE, on joint motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances and Vice-Chairman, Committee on Zoning, Housing & Land Use, severally seconded by Honorable SP Members Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION MADE AND EXECUTED BY EDWIN CON-UI AND SHERYL CON-UI AS DONORS PORTION OF PARCEL OF LAND LOCATED AT BARANGAY LILO-AN, ORMOC CITY, FOR ROAD RIGHT OF WAY PURPOSE, IN FAVOR OF THE CITY GOVERNMENT OF ORMOC AS DONEE;
