RESOLUTION NO. 2015-178

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION (DOD) MADE AND EXECUTED BY EDGARDO C. SABINO AND DAISY R. SABINO AS DONORS OF A PORTION OF A PARCEL OF LAND LOCATED AT BARANGAY LILO-AN, ORMOC CITY, FOR ROAD RIGHT OF WAY PURPOSE, IN FAVOR OF THE CITY GOVERNMENT OF ORMOC AS DONEE.

WHEREAS, an Urgent Indorsement was received by this Thirteenth Sanggunian dated August 24, 2015 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to accept and sign the Deed of Donation by and between Edgardo C. Sabino and Daisy R. Sabino and the City Government of Ormoc, a photocopy of the final Deed of Donation of which is hereto attached and made an integral part hereof;

WHEREAS, the subject DOD has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, and upon its careful and intensive perusal thereof, recommended for the passage of appropriate resolution authorizing the Honorable City Mayor to sign the same, considering that there is no legal impediment as to the execution of the said Deed of Donation;

WHEREAS, the DONORS are the true registered owners of certain parcel of land located at Barangay Lilo-an, this city, which is particularly described as Lot No. 11535-D-2, covered by Certificate of Title No. 53465 and Tax Declaration No. 00947 with a portion of said parcel with Six Hundred Thirty (630) Square Meters to be the subject to this donation;

WHEREAS, as cited in the Deed of Donation, the aforementioned parcel of land donated shall be utilized only as a road right of way by the Donee and not for any other purpose it so desires;

WHEREAS, the DONEE expresses its profound gratitude for this manifestation of affection and act of liberality and generosity on the part of the DONOR and thereby accepts the foregoing donation;

WHEREAS, this august body believes that all the provisions in the Deed of Donation are just and reasonable, the donation as well is deemed beneficial and advantageous to the city, hence, the requested authority of the Honorable City Mayor to accept and sign the same deserves to be accorded the necessary course of action;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances and Vice-Chairman, Committee on Zoning, Housing & Land Use, severally seconded by Honorable SP Members Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga and John Eulalio Nepomuceno O. Aparis II; be it


