*A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR EDWARD C. CODILLA TO ACCEPT AND SIGN THE  
DEED OF DONATION (DOD) MADE AND EXECUTED BY  
JONATHAN S. MAGAN AND MARIZA S. MAGAN AS DONORS  
OF A PORTION OF A PARCEL OF LAND LOCATED AT  
BARANGAY LILO-AN, ORMOC CITY, FOR ROAD RIGHT OF  
WAY PURPOSE, IN FAVOR OF THE CITY GOVERNMENT OF  
ORMOC AS DONEE.*

WHEREAS, this Thirteenth Sanggunian received an indorsement dated August 24, 2015 from the Office of City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to accept and sign the Deed of Donation by and between Jonathan S. Magan and Mariza S. Magan and the City Government of Ormoc, a photocopy of the final Deed of Donation of which is hereto attached and made an integral part hereof;

WHEREAS, the City Legal Officer after a thorough and intensive review of the subject DOD , recommended for its indorsement to this august Body for the passage of appropriate resolution in view of its findings that there is no legal impediment as to the execution of the said DOD;

WHEREAS, the DONORS are the true registered owners of certain parcel of land located at Barangay Lilo-an, this city, which is particularly described as Lot No. 11535-D-3, covered by Certificate of Title No. 53466 and Tax Declaration No. 00948 with a portion of said parcel with Five Hundred Sixty Seven (567) Square Meters to be the subject of this donation;

WHEREAS, the Deed of Donation stipulates that the aforementioned parcel of land donated shall be utilized only as a road right of way by the Donee and not for any other purpose it so desires;

WHEREAS, the DONEE expresses its profound gratitude for this manifestation of affection and act of liberality and generosity on the part of the DONORS and thereby accepts the foregoing donation;

WHEREAS, this august body believes that all the provisions in the Deed of Donation are just and reasonable, the donation as well is deemed beneficial and advantageous to the city, hence, the requested authority of the Honorable City Mayor to accept and sign the same deserves to be accorded the necessary course of action;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances and Vice-Chairman, Committee on Zoning, Housing & Land Use, severally seconded by Honorable SP Members Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno O. Aparis II and Eusebio Gerardo S. Penserga; be it


