RESOLUTION NO. 2015-180

A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT
OF ORMOC IN ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO.009 DATED OCTOBER 16, 2014 OF
LAURA VILLE HOME OWNERS ASSOCIATION INC.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received the application of Laura Ville Home Owners Association Inc., a Civil Society Organization (CSO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, the aforementioned association was organized last March 20, 2015 with office address at Purok 6, Barangay Valencia, Ormoc City and is registered with the Housing and Land Use Regulatory Board under Certificate of Registration No. 00593. It is composed of more or less 200 members mostly informal settlers in affected areas of road widening in different barangays of the city;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: " AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which Ordinance governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) day period within which application for accreditation for membership in Local Special Bodies by any organization shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned application, finds that the same is in order, the purpose of the sought accreditation is for the realization of the association's noble intention to partner with LGU-Ormoc in the implementation of future programs, projects and activities which are deemed beneficial not only to its members but as well as the other sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by Honorable SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, jointly seconded by Honorable SP Members Pedro Godiardo P. Ebcas and John Eulalio Nepomuceno O. Aparis II; be it


