RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY WAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE NO.8 (DA-RFO 8) REPRESENTED BY 173 REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA, *IMPLEMENTATION* OF THE LIVESTOCK INFUSION AND RESTOCKING PROJECT IN ORMOC CITY.

WHEREAS, an indorsement dated September 16, 2015 from the Honorable City Mayor Edward C. Codilla was received by this Sanggunian pertaining to the Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc (LGU-Ormoc) with the Department of Agriculture - Regional Field Office No. 8 (DA- RFO 8) for the implementation of the Livestock Infusion and Restocking Project in Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, one of the mandates entrusted to the DA - RFO 8 is to facilitate the implementation of agricultural programs/projects in the region through the provision of logistical, administrative and technical support to the qualified LGU beneficiaries with the primary goal of achieving food security along with poverty alleviation and promotion of social equity;

WHEREAS, the Livestock Infusion and Restocking Project of DA- RFO 8 which is the object of the MOA is among the flagship projects geared towards the achievement of the aforementioned mandate of the DA-RFO 8. The project recognizes the necessity of infusing new breeder stocks of carabaos and pigs in order to boost livestock production in the city which will serve as a source of stock for farming households envisioned to help reduce rural hunger and malnutrition;

WHEREAS, the MOA stipulates among others, that the DA-RFO 8 shall cause the transfer of funds to LGU-Ormoc in the amount of ONE MILLION TWO HUNDRED THOUSAND PESOS (P1,200,000.00) for the purchase of new breeder stocks of carabaos and pigs for the implementation of said project;

WHEREAS, during the Committee Meeting conducted on the matter, it was gathered that the purchase of the livestock breeder stocks will be undertaken by LGU –Ormoc subject to the specifications set by DA-REO 8. Right after, the purchased breeder stocks will be distributed to qualified farmer-beneficiaries as identified by the City Veterinary Office in accordance with the criteria setforth therein. Furthermore, it was also learned that a separate agreement embodying the terms and conditions for the project availment will be undertaken by LGU-Ormoc thru the City Veterinary Office with the respective farmer-beneficiaries;

WHEREAS, this Sanggunian finds, after close and thorough review of the MOA, that it is extremely advantageous and beneficial to the city particularly to the farmer-beneficiaries as it will help improve the farming communities by increasing their productivity and profitability, therefore most deserving of full support and prompt favorable consideration:

WHEREFORE, foregoing premises considered, on joint motion of Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries and Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by Honorable SP Members Mario M. Rodriguez, Ruben R. Capahi, Antonio M. Codilla, Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
