A RESOLUTION CONFIRMING THE CERTIFICATION OF THE HONORABLE CITY MAYOR EDWARD C. CODILLA DATED MARCH 05, 2015 AS TO THE ACCEPTABILITY OF THE PROPERTIES IDENTIFIED BY THE NATIONAL HOUSING AUTHORITY (NHA) AS FEASIBLE SITE FOR NHA PERMANENT HOUSING PROJECT FOR TYPHOON YOLANDA VICTIMS IN ORMOC CITY.

WHEREAS, an indorsement dated August 18, 2015 from the Honorable City Mayor Edward C. Codilla was received by this august Body requesting for the passage of a resolution confirming his Certification dated March 05, 2015 as to the acceptability of the properties identified by the National Housing Authority (NHA) as feasible site for the NHA Permanent Housing Project for Typhoon Yolanda victims in the city;

WHEREAS, the subject certification was issued by the Honorable City Mayor in response to the letter request emanating from the Regional Office of the National Housing Authority for a Certificate of Acceptance on the property identified by their office as feasible site for their proposed Permanent Housing Project for Typhoon Yolanda victims;

WHEREAS, the properties subject of the Certification are located in Barangay Margen, Ormoc City and particularly described as follows:

WHEREAS, for purposes of determining the feasibility of the aforementioned properties to be utilized as site for housing project, the NHA conducted a physical inspection thereof and as a result a Site Evaluation Report was furnished to this Sanggunian with the recommendation that the proposed Permanent Housing Site is physically suitable for housing development provided that mitigating measures are implemented subject further, to permits and clearances by other concerned authorities particularly the DAR Clearance and ECC, Mines and Geo-Sciences Bureau (MGB), Environmental Management Bureau (EMB), PHILVOCS, and LGU-Ormoc (PALC and Development Permit, etc.);

WHEREAS, this Sanggunian, upon careful review of the matter, concurs with the findings and recommendations of the NHA as to the acceptability of the above-cited lots as a feasible Site for the NHA Permanent Housing Project for Yolanda Victims, thus confirming the certification issued by the Honorable City Mayor relative thereto subject however, to the compliance of existing laws and regulations and the appropriate clearances from the concerned offices. Provided, that the transferee will be in the name of the National Housing Authority (NHA);
