RESOLUTION NO. 2015-200

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND MEMORANDUM OF UNDERSTANDING (MOU) FOR ON SEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE ONE HUNDRED TEN (110) BARANGAY LOCAL GOVERNMENT UNITS (BLGUS) OF ORMOC CITY, REPRESENTED BY THE LIGA NG MGA BARANGAY PRESIDENT, HONORABLE MARIANO Y. CORRO, AND THE VISAYAS STATE UNIVERSITY (VSU) REPRESENTED BY ITS PRESIDENT, JOSE L. BACUSMO FOR THE IMPLEMENTATION OF BARANGAY MANAGEMENT INFORMATION SYSTEM (BMIS).

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated September 21, 2015 requesting for the granting of authority to the Honorable City Mayor to enter into and sign a Memorandum of Understanding (MOU), for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc), with the One Hundred Ten (110) Barangay Local Government Units of Ormoc City, represented by the Liga Ng Mga Barangay-Ormoc City President, Hon. Mariano Y. Corro, and the Visayas State University (VSU), represented by its President, Jose L. Bacusmo, for the implementation of the Barangay Management Information System (BMIS) in the City, a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, the MOU refers to the implementation of BMIS in LGU-Ormoc, which is one of the components of Barangay Integrated Development Approach for Nutrition Improvement (BIDANI) program;

WHEREAS, the BMIS is a people-based information system for gathering, organizing, storing, and updating data about the barangay;

WHEREAS, BMIS software is an innovational access and tool that enables the LGU-Ormoc to attain and generate quality information about the situation of the community which is needed for effective planning, implementation, monitoring, evaluation of development activities, and other useful purposes;

WHEREAS, the One Hundred Ten (110) BLGUs fully recognize the need of relevant, timely and sustainable system of data management which is attainable thru the establishment of BMIS, in effect providing quality and important information for use by the BLGU concerned and LGU-Ormoc in general for its use in various development and monitoring purposes;

WHEREAS, the parties to the MOU fully recognize and extend their cooperation and support for the operationalization of the BMIS in LGU Ormoc, subject to their respective specific roles and responsibilities as stipulated in the MOU, and this Sanggunian, after close and thorough review of the same, finds that it is indeed extremely beneficial to the One Hundred Ten (110) Barangays, and the City in general, and further concludes that the same for also being not contrary to law, agreement, public policy and morals, is most deserving of this august Body's prompt and utmost support and favorable consideration;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by the Honorable SP Members Rolando M. Villasencio, Tomas R. Serafica, Mario M. Rodriguez, Ruben R. Capahi, Vincent L. Rama, Eusepio Gerardo S. Penserga, John Eulalio Nepomuceno C. Aparis II and Mariano Y. Corro; be it
