A RESOLUTION GIVING CONCURRENCE TO THE

DUERO AS CITY GOVERNMENT DEPARTMENT HEAD I
(CITY BUDGET OFFICER), THIS CITY, EFFECTIVE
SEPTEMBER 1, 2015.

WHEREAS, this august Body was in receipt of an Urgent Indorsement dated September 14, 2015 from the Honorable City Mayor Edward C. Codilla pertaining to the appointment of Ms, Sabrina P. Duero as City Government Department Head I (City Budget Officer for the City Government of Ormoc City) effective September 1, 2015, requesting for the concurrence of the same by this Sanggunian;

WHEREAS, said appointment concurrence request was made in accordance with Section 454 Paragraph (D) of Chapter 2 (City Officials in General) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, which provides that:

"X X X, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of the Sangguniang Panlungsod Members, subject to civil service law, rules and regulations. X X X X" (Underscoring supplied).
