RESOLUTION NO. 2015-207

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), REPRESENTED BY ITS REGIONAL DIRECTOR, ELIAS A. CAYANONG, FOR THE ESTABLISHMENT OF DOLE JOB SEARCH KIOSK (JSK).

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated October 9, 2015 relative to the Memorandum of Understanding (MOU) to be entered into by LGU-Ormoc with the DOLE, a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, the DOLE is the national government agency mandated to formulate policies, implement programs and serve as the policy-coordinating arm of the Executive Branch in the field of labor and employment;

WHEREAS, to carry out its mandate to provide Labor Market Information (LMI) and facilitate employment, DOLE operates the Job Search Kiosk (JSK), a stand-alone Labor Market Information system capable of employment facilitation like job search and skills matching facility;

WHEREAS, JSK is an information portal housed in an ATM-type, stand-alone equipment, which provides information on local/overseas job opportunities and other employment-related information. It helps job seekers to fast-track access to relevant information on job openings, and employers' hiring or upgrading requirements through TESDA programs and Bureau of Local Employment (BLE) career guides at no further cost to them;

WHEREAS, the DOLE national and regional offices are linked to the Public Employment Service Offices (PESO) which constitutes the national employment service network under the PESO Act of 1999 and are maintained largely by the LGUs for coordination and technical supervision;

WHEREAS, in a letter dated August 18, 2015, DOLE Chief LEO/Head, WLFO Marites Z. Viñas informed the Honorable City Mayor Edward C. Codilla that LGU-Ormoc is a recipient of a new Phil-Jobnet Kiosk to effectively reach out to the constituents who are actively looking for work, for researchers and future employers who seek to set up economic undertaking in the city and nearby localities;

WHEREAS, the MOU clearly and definitively encapsulates the terms and conditions of the agreement of the parties thereto, including their specific obligations and responsibilities, towards the implementation and attainment of the lofty ends of the DOLE-Job Search Kiosk in Ormoc City, and this Sanggunian, upon thorough review and examination of the MOU, finds that the same will indeed significantly benefit the constituents of Ormoc and the neighboring cities/municipalities, and therefore, is most deserving of its favorable consideration;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C.
