RESOLUTION NO. 2015-213

A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR EDWARD C. CODILLA TO ACCEPT AND SIGN THE  
DEED OF DONATION (DOD) MADE AND EXECUTED BY  
LUCIA S. MAGLASANG, AS DONOR, OF A PORTION OF A  
PARCEL OF LAND DESCRIBED AS LOT NO. 1381-B-5-B  
LOCATED AT BARANGAY ALTA VISTA, ORMOC CITY, FOR  
ROAD RIGHT OF WAY PURPOSE, IN FAVOR OF THE  
LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), AS  
DONEE.

WHEREAS, this august Body was in receipt of an indorsement dated October 2, 2015 from the Office of City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to accept and sign the Deed of Donation by Lucia S. Maglasang, DONOR, in favor of LGU-ORMOC, DONEE, a photocopy of the final and revised Deed of Donation with technical description of the portion of the property to be donated are hereto attached and made an integral part hereof;

WHEREAS, the DONOR is the true registered owner of certain parcel of land located at Barangay Alta Vista, this city, which is particularly described as Lot No. 1381-B-5-B of the subdivision plan, Psd-08-028377-D, being a portion of Lot 1381-B-5, Psd-08-019758-D, covered by Certificate of Title No. 45707 and Tax Declaration No. 00084-00336 with an area of Eight Hundred Thirty Four (834) Square Meters;

WHEREAS, as provided for in the Deed of Donation only a portion of the above described parcel of land consisting of an area of Ninety One (91) square meters more or less shall be subject of the donation to LGU-Ormoc for purpose of Road Right of Way and other purposes connected to the same;

WHEREAS, the subject DOD has passed through the scrutiny of the City Legal Officer Atty. Ivan Verallo with the findings on his part in an indorsement dated October 2, 2015 stating that there is no legal impediment for its execution and therefore recommending for the passage of a resolution authorizing the City Mayor to sign the same;

WHEREAS, the DONEE expresses its profound gratitude for this gesture and manifestation of affection and act of liberality and generosity on the part of the DONOR and accepts the foregoing donation as it is for purposes extremely beneficial to the City and its constituents;

WHEREAS, this Sanggunian, after thorough examination of the same, finds that the provisions of the Deed of Donation are just and reasonable, that it is not contrary to law, existing contract and public policy, and that it is deemed beneficial and advantageous to the City and therefore, deserving of its prompt favorable action, and additionally, with this Sanggunian expressing its deep appreciation for such profound and unselfless magnanimity shown by the DONOR;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos Jr., Chairman Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Antonio M. Codilla, Vincent L. Rama, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


