A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF COCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC),
THE FOLLOWING PARTIES: SAND AND GRAVEL PERMITTEE, CELEDONIA S. CATINGUB, THE MINES AND GEOSCIENCES BUREAU (MGB) REGIONAL OFFICE NO. VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, ENGR. ALILO C. ENSOMO JR.; THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGIONAL OFFICE NO. VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, MR. LEONARDO R. DIMSON, FOR THE **ESTABLISHMENT** OF CONTINGENT LIABILITY A REHABILITATION FUND (CLRF) COVERING THE SAND AND GRAVEL INDUSTRIAL PROJECT OF CELEDONIA S. CATINGUB IN BARANGAY CAN-UNTOG, THIS CITY.

WHEREAS, this Thirteenth Sanggunian was in receipt of an Indorsement dated September 11, 2015 from the Office of the City Mayor relative to a request for the granting of authority to the Honorable City Mayor to sign and enter into a Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc (LGU-ORMOC) with the following: the Mines and GeoSciences Bureau (MGB) Regional Office No. 8, the Department of Environment and Natural Resources (DENR) Regional Office No.8, the Environmental Management Bureau (EMB) Regional Office 8, the Pollution Control Association of the Philippines, and Ms. Celedonia S. Catingub, a photocopy of the final MOA is hereto attached and made an integral part hereof;



WHEREAS, the MOA relates to the need of establishing a Contingent Liability Rehabilitation Fund (CLRF) which will specifically cover the sand and gravel industrial project of Celedonia S. Catingub pursuant to Section 180 of DENR Administrative Order (DAO) No. 2010-21, providing for the Implementing Rules and Regulations of R.A. 7942 otherwise known as the "Philippine Mining Act of 1995";

WHEREAS, Celedonia S. Catingub is a holder of a Sand and Gravel Industrial Permit, IP-21012-017-VIII covering an aggregate area of 12.9053 hectares located along Bagombong and Sumaad Rivers, Brgy. Can-Untog, Ormoc City;

WHEREAS, CLRF is an environmental guarantee fund mechanism to ensure just and timely compensation for damages and progressive and sustainable rehabilitation for any adverse effect a mining operation or activity may cause;

WHEREAS, as provided for in the MOA the CLRF shall be established and maintained by each operating Contractor/Permit Holder as a reasonable environmental deposit to ensure availability of funds for the satisfactory compliance with the commitments and performance of the activities stipulated in the Environmental Protection and Enhancement Program (EPEP)/ Annual Environmental Protection and Enhancement Program (AEPEP) during specific project phase; it shall be deposited as a Trust Fund in a Government depository bank and shall be used for monitoring as well as in the physical and social rehabilitation of areas and communities affected by mining activities and for research on the social, technical and preventive aspects of rehabilitation;

WHEREAS, the parties to the MOA are mutually committed in collaborating for the successful establishment of the Contingent Liability and Rehabilitation Fund in accordance with the provisions of the law, subject to their corresponding specific obligations and responsibilities, as stipulated in the MOA, and this Sanggunian finds, after close and thorough review of the same, that the MOA is not contrary to law, contract, public policy and public morals, and that its goals are indeed beneficial for the City, and so therefore, most deserving of this august Body's full and prompt support and favorable action;
