RESOLUTION NO. 2015-225

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE BUREAU OF SOILS AND WATER MANAGEMENT (BSWM), REPRESENTED BY ITS EXECUTIVE DIRECTOR, SILVINO Q. TEJADA, CESO III, AND THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA, CESO III, FOR THE ESTABLISHMENT OF COMPOSTING FACILITY FOR BIODEGRADABLE WASTES (CFBW) AS GRANT PROJECT UNDER THE NATIONAL ORGANIC AGRICULTURE PROGRAM (NOAP) OF THE DEPARTMENT OF AGRICULTURE.

WHEREAS, an Indorsement was received by this Thirteenth Sanggunian dated October 19, 2015 from the Office of the City Mayor Edward C. Codilla requesting for the passage of a resolution authorizing Him to enter into and sign a Memorandum of Agreement (MOA) by and between the Bureau of Soils and Water Management (BSWM), the Department of Agriculture -Regional Field Office 8, and the Local Government Unit of Ormoc (LGU-ORMOC), a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA relates to the establishment of CFBW which is composed of one (1) unit rotary composter, one (1) unit size reduction machine and one (1) unit of decomposing micro-organism multiplier machine in LGU-Ormoc through the City Agriculture Office in collaboration with the BSWM and DA-RFO 8;

WHEREAS, the CFBW project is in line with the priority thrust of the National Organic Agriculture Program (NOAP) which complements and supports DA plans and programs to increase crop productivity through sustainable agriculture;

WHEREAS, the establishment of the composting facility is considered an advent towards the efficient processing of biodegradable wastes to be produced as organic fertilizers for the use of the marginal farmers which in effect would reduce the vulnerability of these farmers on the high cost of chemical fertilizers and promote the gradual adoption of organic agriculture in the city;

WHEREAS, both BSWM and DA-RFO supports the Philippine Ecological Solid Waste Management Act (RA 9003) which emphasized the use of environmentally - sound methods that maximize the utilization of valuable resources and encourage resource conservation and recovery thus, initiates the implementation of the CFBW project;

WHEREAS, in support to R.A.No.10068 otherwise known as the Organic Agriculture Act of 2010, the BSWM likewise continuously implement means to help alleviate the problems of market waste disposal as well as the industrial waste and community garbage disposal through appropriate methods of sorting, collecting and composting;

WHEREAS, the DA-RFO being the DA's implementing agency in charge and responsible of agricultural programs has technical and logistical capability to handle for the implementation and enforcement on the establishment of CFBW;

WHEREAS, the parties to the agreement are mutually committed in collaborating for the successful establishment of the CFBW, subject to their corresponding specific obligations and responsibilities, as stipulated in the MOA, and this Sanggunian, after close and thorough review of the same, finds that it is indeed beneficial to the farmers, and the City in general, and so therefore, most deserving of this august body's utmost support and favorable consideration;

WHEREFORE, on joint motion of the Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture & Fisheries and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances, severally seconded by the Honorable SP Members Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
