CODILLA TO ENTER INTO AND SIGN THE SIX (6) SEPARATE MEMORANDUM OF AGREEMENTS (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA, CESO III, AND THE FOLLOWING FARMERS' ASSOCIATION FOR THE IMPLEMENTATION OF THE HIGH YIELD TECHNOLOGY ADOPTION PROJECT THROUGH A GRANT RECOVERY ROLL - OVER SCHEME, TO WIT:

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated October 19, 2015 requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to sign the MOAs by and between the DA-RFO 8, the six (6) Farmers Association as enumerated above, and LGU-Ormoc, a photocopy of the final MOAs are hereto attached and made an integral part hereof;

WHEREAS, the MOA refers to the implementation of the High Yield Technology Project in Ormoc City through a Grant Recovery Roll – Over Scheme in support of the development of a seed and input supply base in the rural farming communities to enhance accessibility of quality hybrid rice seeds and fertilizers for the farmers;

WHEREAS, LGU-Ormoc and the different farmers' association in partnership with the DA-RFO 8 are willing to undertake and participate in the implementation of the said project as well as committed to support the objectives of the same;

WHEREAS, the DA-RFO 8 will procure the hybrid seeds and fertilizers for the recipient farmers under the "Grant Recovery Roll Over Scheme", a program provided to the farmers' association/organization to achieve maximum yield potential;

WHEREAS, the parties thereto have agreed to perform committedly their therein described obligations and responsibilities towards the achievement and implementation of the MOA, and this Sanggunian finds, after close and thorough review of the same, that it is extremely beneficial to the rice farmer - beneficiaries in the matter that it will greatly help improve the farming communities by increasing their productivity and profitability, and so therefore, is most worthy of this august Body's prompt favorable consideration and support;


ADOPTED, November 12, 2015.
