THE DEED OF DONATION (DOD) FOR AND ON BEHALF OF

AS DONEE, WITH THE DEPARTMENT OF ENERGY - VISAYAS
FIELD OFFICE (DOE-VFO), REPRESENTED BY DIRECTOR
ANTONIO E. LABIOS, AS DONOR, OF ONE (1) UNIT 10 -
LITER CALIBRATING BUCKET WITH SERIAL NUMBER 25822.

WHEREAS, this august Body was in receipt of an Indorsement dated
November 4, 2015 from the Office of the City Mayor requesting for the passage of a
resolution authorizing the Honorable City Mayor Edward C. Codilla to sign the Deed
of Donation by and between the Department of Energy - Visayas Field Office (DOE-
VFO), DONOR, of one (1) unit 10 - liter calibrating bucket with Serial Number
25822, in favor of LGU-Ormoc, DONEE, a photocopy of the final Deed of Donation is
hereto attached and made an integral part hereof;

the said calibrating bucket in good condition and also be responsible for re-
calibration of the same;
