RESOLUTION NO. 2015-231

A RESOLUTION EXTENDING AUTHORITY TO THE ORMOC CITY SPORTS COUNCIL AS HOST AND ORGANIZER, IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, TO SELL TICKETS OF THE PHILIPPINE COLLEGIATE CHAMPIONS LEAGUE (PCCL) VISAYAS REGIONAL ELIMINATIONS AND THE PHILIPPINE COLLEGIATE CHAMPIONS LEAGUE (PCCL) VIS MIN ZONAL GAMES TO BE HELD ON DECEMBER 5 - 7, 2015 AND ON DECEMBER 8 - 10, 2015 AT THE ORMOC CITY SUPERDOME.

WHEREAS, this august Body was in receipt of an Urgent Indorsement dated November 11, 2015 from the Office of the City Mayor regarding the request of the Ormoc City Sports Council Vice-Chairman, Hon. Ruben R. Capahi, requesting for the approval on their intention to sell tickets for the upcoming PCCL Regional Eliminations and the PCCL Vis Min Zonal Games;

WHEREAS, the said sports event will be hosted by the City Government of Ormoc through the Ormoc City Sports Council, in cooperation with the Ormoc City Schools Sports Organization (OCSSO) and the Philippine Collegiate Champions League (PCCL);

WHEREAS, the PCCL Regional Eliminations Games will be participated by six (6) Collegiate Varsity teams from Ilo-Ilo, Bohol, Bacolod, Dumaguete, Roxas City and Ormoc City;

WHEREAS; the Vis Min Zonal Games will also be participated by the Mindanao Champion Team, the Visayas Regional Elimination Champion, and the 2nd and 3rd place teams of the CESAFLI League of Cebu namely the Green Lancers of the University of the Visayas, and the Jaguars of the University of San Jose Recoletos;

WHEREAS, the abovementioned events will be held on December 4, 5, 6 and 7, 2015 for the Visayas Regional Elimination, while the Vis min Zonal games will be held on December 8, 9 and 10, 2015 at the Ormoc City Superdome;

WHEREAS, 100 pieces of patron tickets at Php500.00 each will likewise be sold to the public;

WHEREAS, it is the intention of the organizers, the Ormoc City Sports Council and the Ormoc City Schools Sports Organization (OCSSO) to shoulder and pay all expenses related to the event including the 10% Superdome Obligation and the remaining Net Balance will be turned over to the Ormoc City Treasury, after all expenses shall be paid and a Financial Statement relative thereto shall be submitted to the concerned agencies for information;

WHEREAS, as required under Ordinance No. 64, Series of 1997, otherwise known as "AN ORDINANCE GOVERNING THE OPERATION AND MANAGEMENT OF THE ORMOC CITY SUPERDOME, AND THE FIXING OF THE RENTALS, FEES AND OTHER CHARGES FOR THE USE THEREOF", the permission of the Sangguniang Panlungsod is needed, hence this request from the Ormoc City Sports Council;


