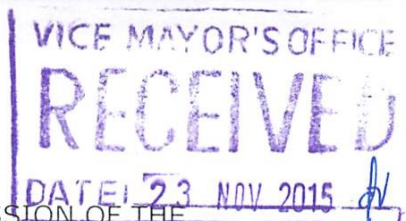

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA, CESO III, FOR THE PROVISION OF ONE (1) UNIT FRUIT DEHYDRATOR AS GRANT UNDER THE DEPARTMENT OF AGRICULTURE - HIGH VALUE CROPS DEVELOPMENT PROGRAM (DA-HVCDP) COMPONENT.

WHEREAS, an Indorsement was received by this august Body dated October 29, 2015 from the Honorable City Mayor Edward C. Codilla requesting for the passage of a resolution authorizing his Honor to enter into and sign a Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc (LGU-ORMOC), and the DA-RFO 8, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA concerns the provision of one (1) unit Fruit Dehydrator by the DA-RFO8 to the Office of the City Agriculture of LGU-Ormoc, as the direct beneficiary, which equipment shall be used for the benefit of High Value Crop farmers in the city;

WHEREAS, the DA-HVCDP through its Regional Field Office No. 8, has its objective to deliver appropriate development support systems and facilities, to harmonize development interventions in strategic production area(s)/zone(s), and farm households;

WHEREAS, the provision of the Fruit Dehydrator is one of the components of the DA-HVCDP to the qualified Non-Government Organizations (NGO's), People's Organization (PO's) and Local Government Units (LGU's) with the aim to modernize the agriculture sector through transformation from resource-based to a technology-based industry;

WHEREAS, LGU-ORMOC signified its intention to be one of the recipients of one (1) unit Fruit Dehydrator from DA-RFO8 for the implementation of the DA-High Value Crops Development Program to transmute the fruit production cluster areas into modern agribusiness systems through farm mechanism;

WHEREAS, the Fruit Dehydrator is deemed very useful in the preservation and processing of fruits which are abundant in certain season hence, will eventually help the farmers in the proper storage and have the opportunity to obtain higher profits in the marketing of their fruit products;

WHEREAS, the parties to the agreement are mutually committed to perform their corresponding specific obligations and responsibilities, as stipulated in the MOA, and this Sanggunian finds, after close and thorough review of the same, that it is indeed beneficial to the city particularly to the qualified NGOs and POs, whose members are actively engaged in the production of High Value Crops, and so therefore, most deserving of this august body's utmost support and favorable consideration;
